### **Recommendation:**

Discussion.

### **Background:**

As part of the RDBN Connectivity Strategy development, criteria and metrics for prioritizing projects must be established to facilitate a logical order for planning and establishing attainable goals. Staff are proposing metrics and asking for other metrics the Committee would like considered.

Considerations for prioritization will remain responsive to individual Director's unique considerations for their area in consultation with staff and Partners, though staff recommend that considerations for establishing priorities should always include:

- 1) Logical sequencing of construction (building off existing infrastructure).  
 This will be a particularly important consideration for fibre to the home projects, as transport fibre cannot be constructed in isolated segments. It will also be a consideration for wireless projects, as towers require fibre to operate. For example, existing or planned fibre builds in member municipalities and First Nations communities may provide a core from which to partner and extend service with considerable cost savings.
- 2) Population density – lowest cost per home passed.  
 Staff have developed and tested a costing formula to help rank projects in an area based on lowest cost per home passed. While the formula uses a cost factor, the formula is not intended to provide accurate project costing but allow projects in an area to be compared against each other.
- 3) Existing service levels – areas with some service may fall below areas with no service.  
 While we understand that all residents have a degree of dissatisfaction with their current service levels and our goal is to ensure everyone has access to speed at or above the minimum standard, some areas stand out as having no service at all. Though they may not have a high population density, where possible,

projects may be developed to serve un-served areas before projects are developed to serve under-served areas.

- 4) Areas that are eligible for federal and provincial funding (area with less than 50/10 service).

Conversations around Innovation, Science and Economic Development (ISED) speed mapping and how connectivity speeds are reported for the purpose of grant eligibility is currently a topic of conversation at several levels of government. UBCM and the Ministry of Citizen Services commissioned an Internet Speed Study to review the mapping of internet speed data, the results of which are expected soon.

While the nature of connectivity planning requires the ability to shift quickly with new information, prioritization criteria will allow staff and Directors to work with partners on the implementation of short, immediate, and long-term goals through Strategic Implementation Phases.

The RDBN Connectivity Strategy will propose that the build-out of infrastructure for prioritized projects involve three phases:

#### Phase 1: Design

In this Phase, RDBN Staff and Directors will work with Partners to finalize project boundaries and best infrastructure for the service area. Partner staff will design the project, including all technical components, and provide a final cost estimate.

#### Phase 2: Funding

Once designed, the RDBN and Partner will indicate their own level of financial contribution to the capital project budget. For the RDBN this contribution can be made via available allocations of the Canada Community-Building Fund (Previously Federal Gas Tax – Community Works Fund).

In many cases, these combined contributions will not be the full amount required to fund a rural infrastructure build.

For the remainder of the project budget, we will first consider pursuing grant funding from senior levels of government via Provincial and Federal Connectivity Infrastructure Funding. This funding is critical to the implementation of rural connectivity infrastructure, though it does present challenges due to high rates of over-subscription and long processing timelines.

It may be the case that not all projects will be eligible for grant funding or that, despite eligibility, project costs and cost per home passed are too high to have a good chance of success in a competitive grant program. In these cases, alternative budgeting considerations may be investigated, including:

- Partnerships with First Nations governments and member municipalities
- In-Kind Community Contributions

- Partnerships with Industry
- Reinvestment of RDBN revenue generated through P3 agreements

In some cases, where senior government grant funding is not an option, alternative funding mechanisms may need to be investigated. These mechanisms would take significant time and resources as they would require service establishment based on a specific project boundary through a referendum. These mechanisms will be considered on a specific project basis, and not for the Region as a whole and may include:

- Taxation for capital costs
- Borrowing from MFA for capital costs

### Phase 3: Build

Once funding has been confirmed for the project, a build timeline will be provided by the Partner for the project area(s).

The three phases of each Priority Project will occur in a ladder approach to ensure that projects are moved along the process and RDBN projects will (wherever possible) be ready in advance of grant funding opportunity announcements. For example, once the immediate priority project reaches the 'Fund' phase, the next project in line will enter the 'Design' phase to facilitate a continuous progression. The length of time a project remains at each stage (particularly the 'Fund' stage) is subject to variables outside our control and will vary from project to project and EA to EA.
