Dear Gerry Thiessen:

Thank you for your letter of January 6, 2022, regarding our December meeting and the regional district's commitments to build relationships and collaborate with local First Nations to foster healthy ecosystems and economies.

I am pleased to hear about your considerations and planned work with the Ministry of Municipal Affairs with respect to Indigenous participation in regional district boards. As you know, on January 7, 2022 the Honourable Justice Kent released his reasons for decision (BC Supreme Court) relating to the litigation initiated by Saik'uz and Stelat'en First Nations in 2011. The Court issued two declarations: (i) the first declaration recognized that Saik'uz and Stelat'en have an Aboriginal right to fish the Nechako watershed for food, social and ceremonial purposes; and (ii) the second declaration that "As an incident of the honour of the Crown, both the provincial and federal governments have an obligation to protect that Aboriginal right."

We have been reviewing the reasons for decision and in the coming weeks will be exploring with the Saik'uz, Stelat'en and Nadleh Whut'en First Nations how best to address these matters. We will continue to raise in those discussions the topic of how to effectively engage with local and regional governments and others potentially affected by any future agreements during negotiations and implementation.

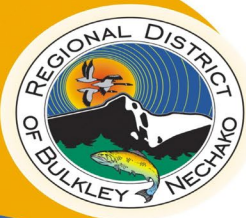

Dear Minister Rankin,

On behalf of the Regional District of Bulkley-Nechako (RDBN), I would like to thank you and your staff for taking the time to meet with us on December 15, 2021. It is great to hear your commitment to including local governments at the negotiation and agreement tables and that our inclusion in these discussions should not be an afterthought.

As you noted, across our region, we have many agreements and negotiations between the Province and First Nation governments occurring that would see these Nations moving ahead with self-determination in a variety of different forms. Our Regional District is committed to working alongside and in collaboration with local First Nations and building those relationships to foster healthy ecosystems and economies. Our commitment to these relationships is evident in our recently signed MOU with the Nechako First Nations and the continued work of our First Nations Liaison.

Our discussion of the Non-Disclosure Agreement (NDA) covered talks with the Province, Rio Tinto, and the Nechako First Nations, and your commitment to broach the idea of our inclusion within these talks is highly positive. We are optimistic that through our inclusion, our region could meaningfully advance environmental stewardship that would balance Indigenous and non-Indigenous social, recreational, and economic values that would benefit all living and working within the region. As local government elections will be occurring in the fall of 2022, any advancement we can make on our inclusion on the NDA prior to the elections would allow us to not only gain momentum but ensure that efforts would not be halted or hindered by it.

As these government-to-government discussions are important to ensuring that our collective action is moving positively in the direction of greater reconciliation across the region and province, we would welcome the opportunity to have regularly scheduled meetings with your staff to keep each other apprised of developments pertaining to the Pathways Forward 2.0 and other agreements within our region.
