## NECHAKO SOUTHEAST AREA FIRES EVACUATION ALERT RESCINDED August 2, 2023 at 1730 hours

Upon recommendations from BC Wildfire Service, the **Evacuation Alert** issued by Saik'uz First Nation, the Village of Fraser Lake, the Regional District of Bulkley-Nechako, and Recreation Sites and Trails BC on July 19, 2023 at 1030 hours **has been rescinded, as shown on the attached map.**

**The Evacuation Alert issued on August 2, 2023 at 1730 by Saik'uz First Nation, Recreation Sites and Trails BC, and the Regional District of Bulkley-Nechako for the Finger Lake Wildfire (#G41195) remains in place.**

**The Evacuation Alert issued on August 1, 2023 at 1030 hours by the Regional District of Bulkley-Nechako for the Lucas Lake Wildfire (#G41380) remains in place.**

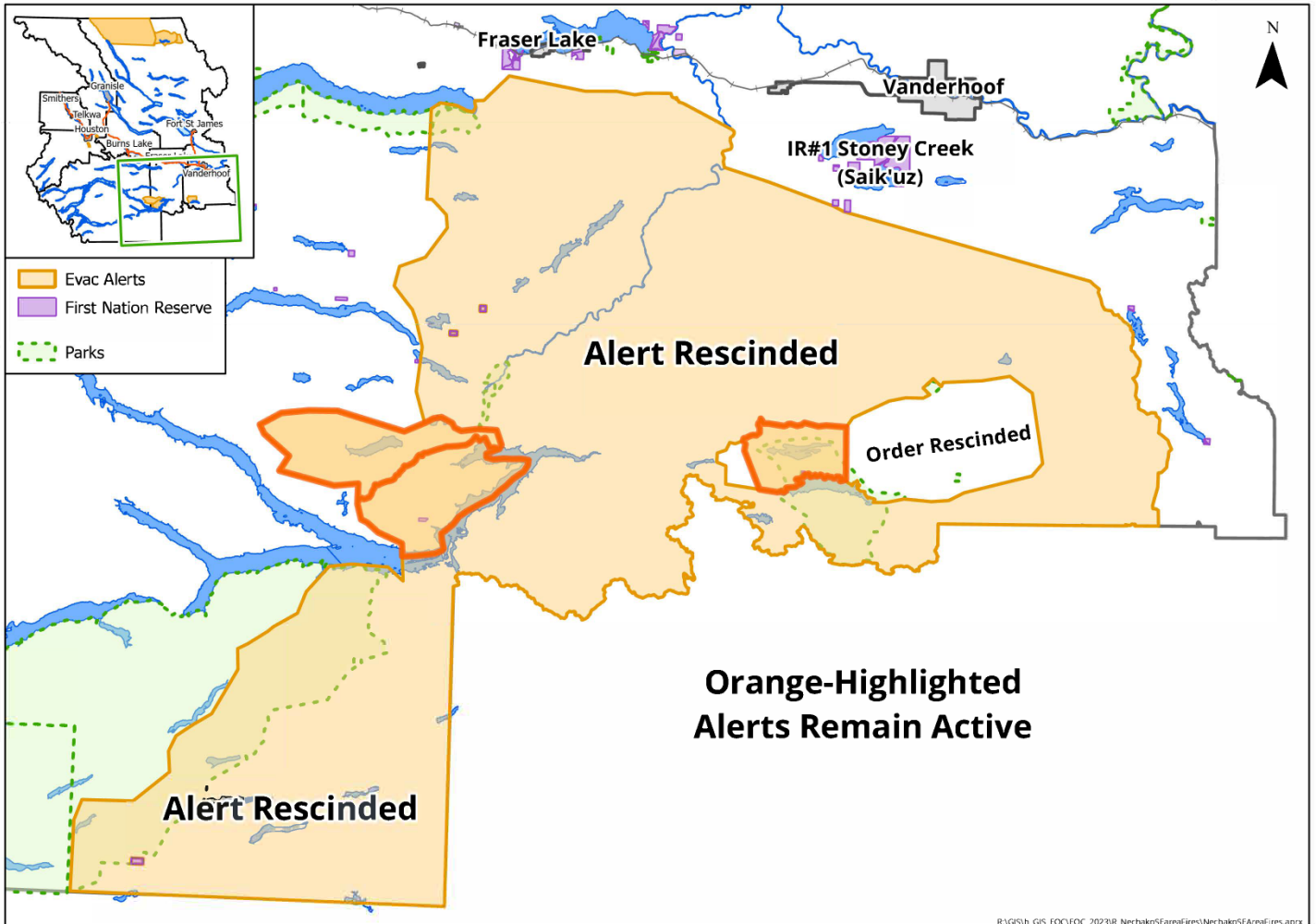

## NECHAKO SOUTHEAST AREA FIRES EVACUATION ALERT AMENDMENT July 19, 2023 at 1030 hours

Upon recommendations from BC Wildfire Service, the Evacuation Alert Expansion issued by Saik'uz First Nation, the Village of Fraser Lake, the Regional District of Bulkley-Nechako, and Recreation Sites and Trails BC on July 15, 2023 at 0900 hours is amended for the following area:

**All lands and properties from the intersection between Dahlgren & Nithi Roads, northeast to the hydro line right of way. It follows the hydro ROW East for approximately 22.5km to the unnamed creek feeding Leg Lake. It follows the watercourse southeast, then continues southeast to the Nechako River. It follows the Nechako south for approx. 6.5km, then shifts southeast hitting the intersection between Kenney Dam and Greer Valley Rd, as well as the south-west corners of the CORKSCREW CREEK 9 and 10 reserves (Saik'uz First Nation), continuing until the Bobtail and Bobtail Connector FSR intersection, as shown on the attached map.**

**The Evacuation Order issued July 14, 2023 at 2000 for the Finger Lake Wildfire (#G41195) remains in place.**

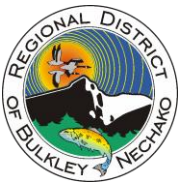
**The Evacuation Order issued July 16, 2023 at 1530 for the Lucas Lake Wildfire (#G41380) remains in place.**

An Evacuation Alert has been issued to prepare you to evacuate your premises or property should it be found necessary. Residents will be given as much advance notice as possible prior to evacuation, however, you may receive limited notice due to changing conditions.

### WHAT YOU SHOULD DO WHILE THIS ALERT IS IN EFFECT

Be prepared for an Evacuation Order:

- Locate all family members or co-workers and plan to meet outside the evacuation area, should an evacuation be called while separated.
- Gather essential items such as medications, eyeglasses, valuable papers (i.e., insurance), immediate care needs for dependents and, if you choose, keepsakes (photographs, etc.), and have these items readily available for quick departure.
- Prepare to move any persons with mobility challenges and/or children.
- Move pets and livestock to a safe area. If you require assistance, please call the Regional District of Bulkley-Nechako.
- Arrange to transport your household members or co-workers in the event of an evacuation order. If you are asked to evacuate and need transportation assistance from the area, please call the Regional District of Bulkley-Nechako.
- Arrange accommodation for your family if possible.

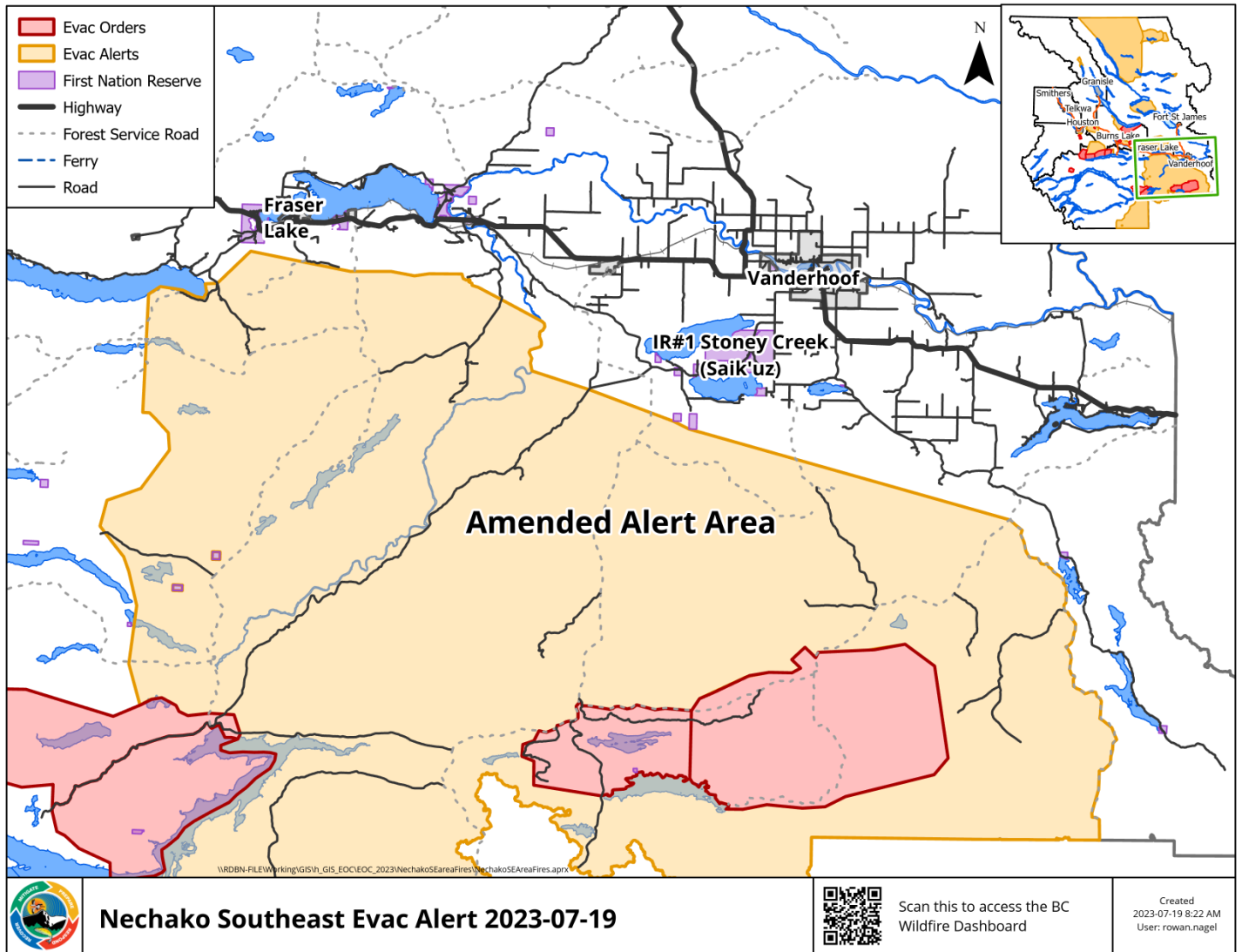

## Nechako Southeast Area Fires EVACUATION ALERT EXPANSION July 15, 2023 at 0900 hours

An Evacuation Alert Expansion has been issued **due to potential danger to life and health** by Saik'uz First Nation, Recreation Sites and Trails BC, the Village of Fraser Lake, and the Regional District of Bulkley-Nechako due to a wildfire. This expansion broadens the Evacuation Alert issued on July 12, 2023 at 2130 and is for the following area:

**All lands and properties south of Highway 16 and East of Stellaquo 1 (Stella'en First Nation), only the properties South of Highway 16 within the municipal boundaries of the Village of Fraser Lake. Adjacent to Tachick Lake, Nulki Lake, Sinkut Lake, including Saik'uz First Nation (IR#1 Stoney Creek, IR#2 Sackanitecla, IR#3 Laketown, IR#4 Old Country Meadow, IR#5 Clustalach, IR#8 Sinkut Lake, IR#9 Corkscrew Creek, IR#10 Corkscrew Creek), and West of Mapes Road, as shown on the attached map.**

An Evacuation Alert has been issued to prepare you to evacuate your premises or property should it be found necessary. Residents will be given as much advance notice as possible prior to evacuation, however, you may receive limited notice due to changing conditions.

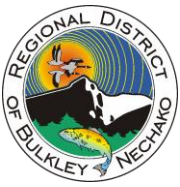

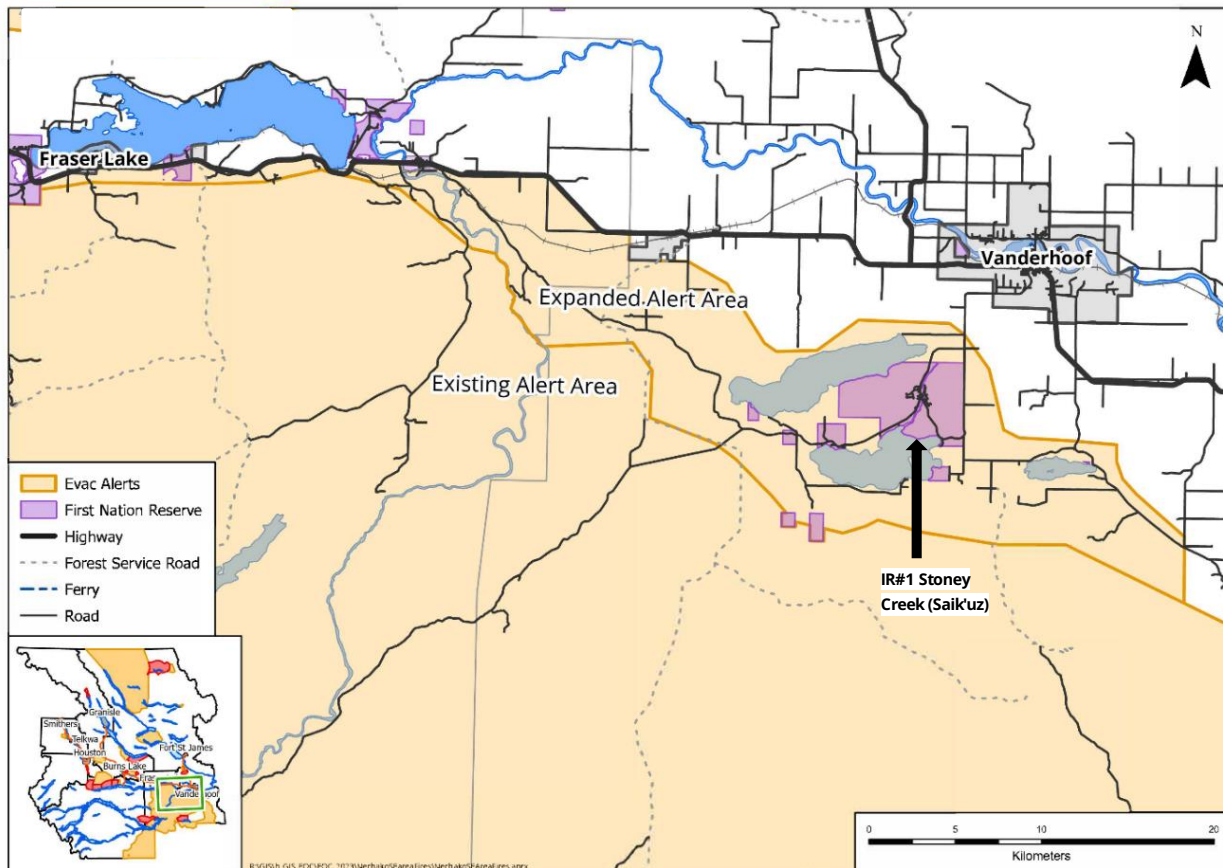

# EVACUATION ALERT

## **Nechako Southeast Area Fires EVACUATION ALERT ISSUED July 12, 2023 at 2130 hours**

Upon recommendations from BC Wildfire Service, an Evacuation Alert has been issued by the Regional District of Bulkley-Nechako due to a wildfire.

Because of the potential **danger to life and health** BC Parks and the Regional District of Bulkley-Nechako have issued an Evacuation Alert **for all land and properties south of the Power Line Right of Way to the southern boundary of the Regional District and west of the Blackwater Rd., excluding the boundary of the Village of Fraser Lake and IRs, as shown on the attached map.**

An Evacuation Alert has been issued to prepare you to evacuate your premises or property should it be found necessary. Residents will be given as much advance notice as possible prior to evacuation, however, you may receive limited notice due to changing conditions.

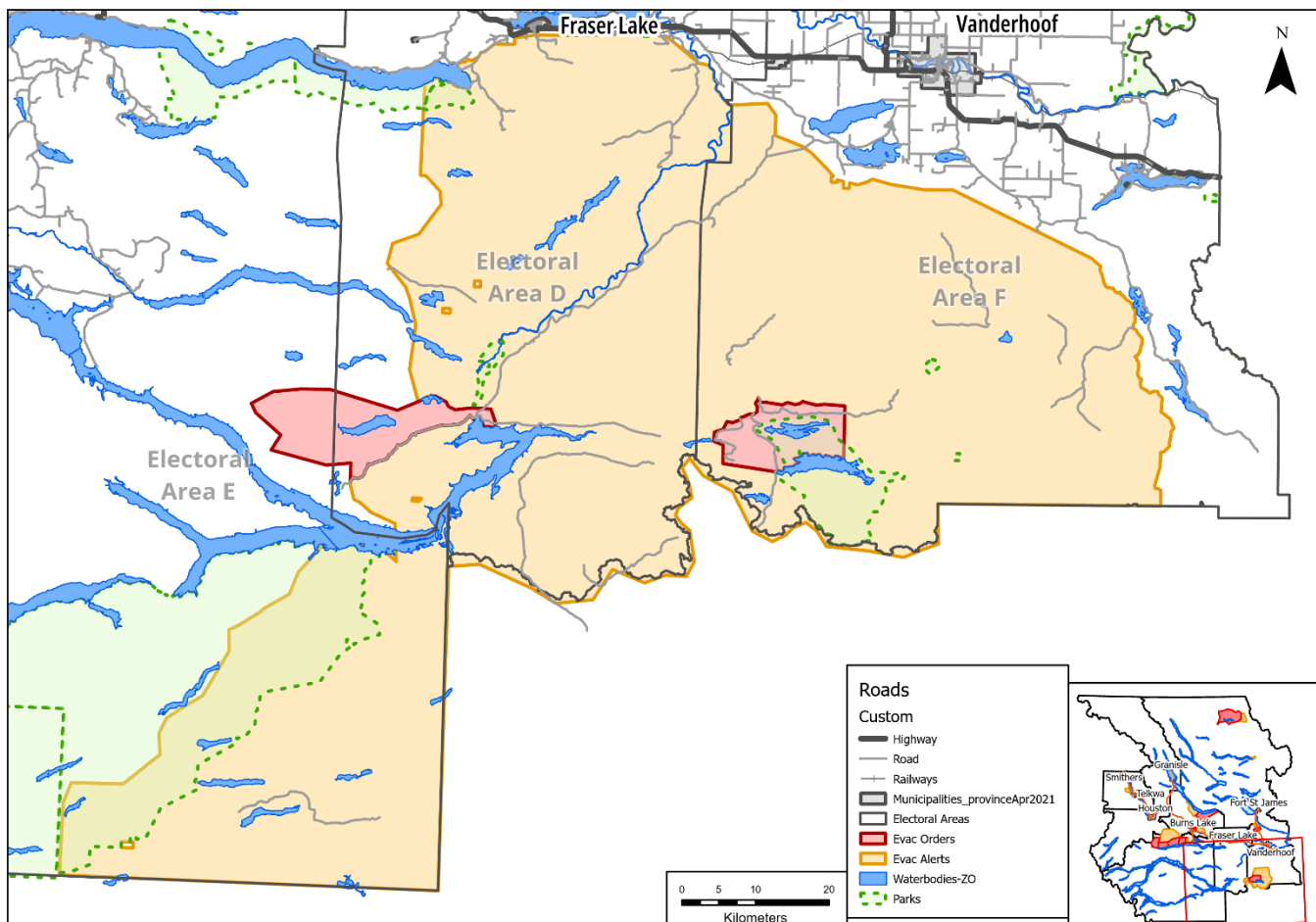
