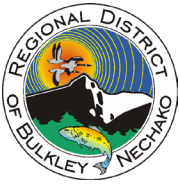

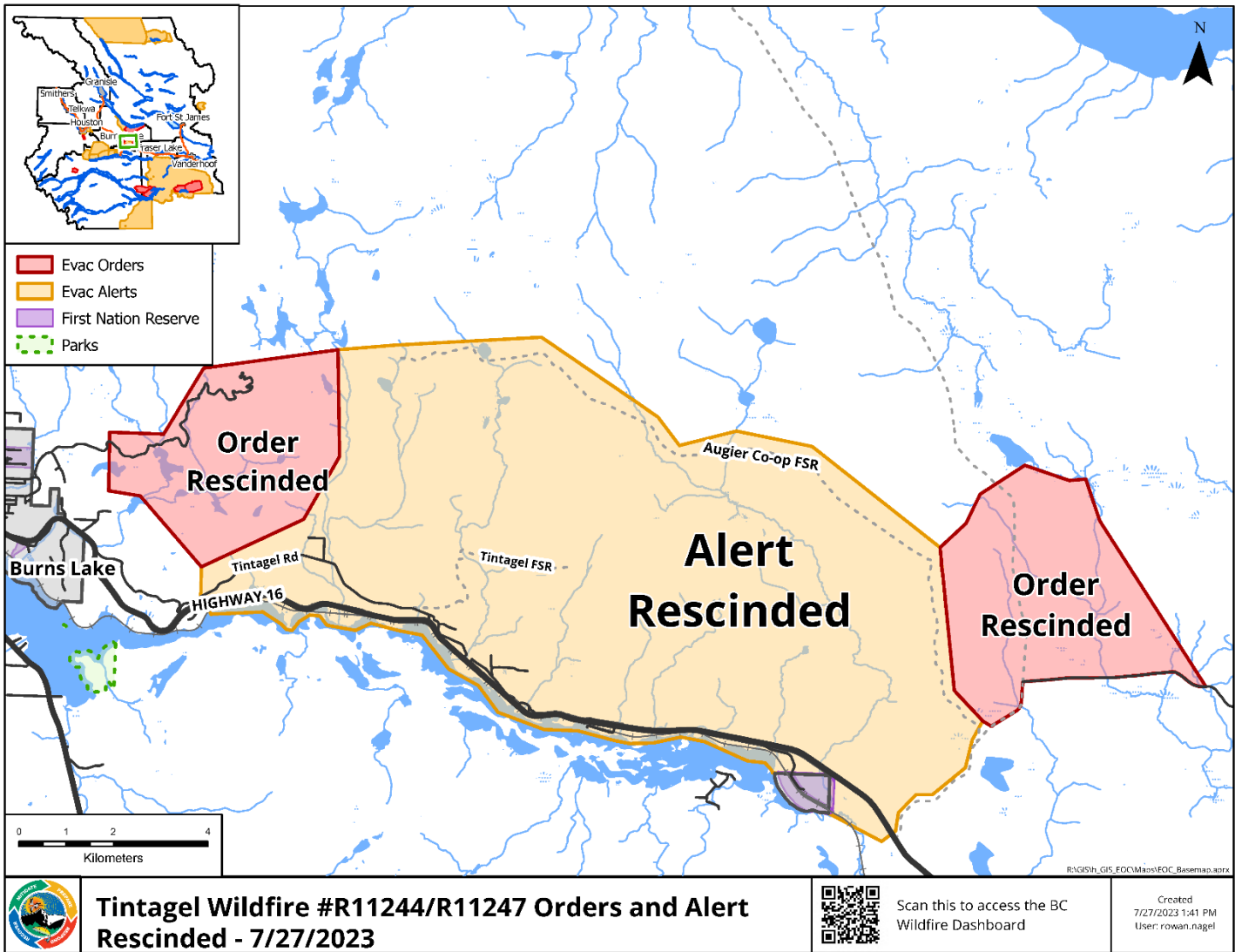

# EVACUATION ORDER

## Tintagel Wildfires #R11244/R11247 EVACUATION ORDER ISSUED July 11, 2023 at 1730 hours

An Evacuation Order has been issued by the Regional District of Bulkley-Nechako effective **July 11, 2023 at 1730 hours** due to a wildfire.

Because of the **danger to life and health** the Regional District of Bulkley-Nechako has issued an Evacuation Order for **all lands and properties east of the existing Tintagel Evacuation Alert Area and north of Co-op Lake, accessed by Augier Main Forest Service Road, and extending east on the north side of Hannay Road, as shown on the attached map.**

### **YOU MUST LEAVE THE AREA IMMEDIATELY AND REGISTER AT THE RECEPTION CENTRE**

**Persons who disregard this Evacuation Order and remain in the Evacuation Order area do so at their own risk. The Regional District of Bulkley-Nechako may be unable to assist anyone who remains in the Evacuation Order area.**

- If you need transportation assistance from the area, please advise the individual providing this notice or call the Regional District of Bulkley-Nechako at **250-692-1553**.
- Close all windows and doors.
- Shut off all gas and electrical appliances, other than refrigerators and freezers.
- Close gates (latch) but do not lock.
- Gather your family: take a neighbour or someone who needs help.
- Take critical items (medicine, purse, wallet, and keys) only if they are immediately available. Take pets in pet kennels or on a leash.
- Do not use more vehicles than you must.
- If you require assistance for livestock, please call the Regional District of Bulkley-Nechako at **250-692-1553**.

### **Evacuees:**

- Register at the Reception Centre at the **Village of Burns Lake Multiplex** at 103 Flogum Street, Burns Lake or contact the Emergency Support Services Director at **250-692-9901**.
- Emergency Support Services can provide assistance for food, accommodation, hotel or staying with friends and family, clothing, emotional support, and family reunification.

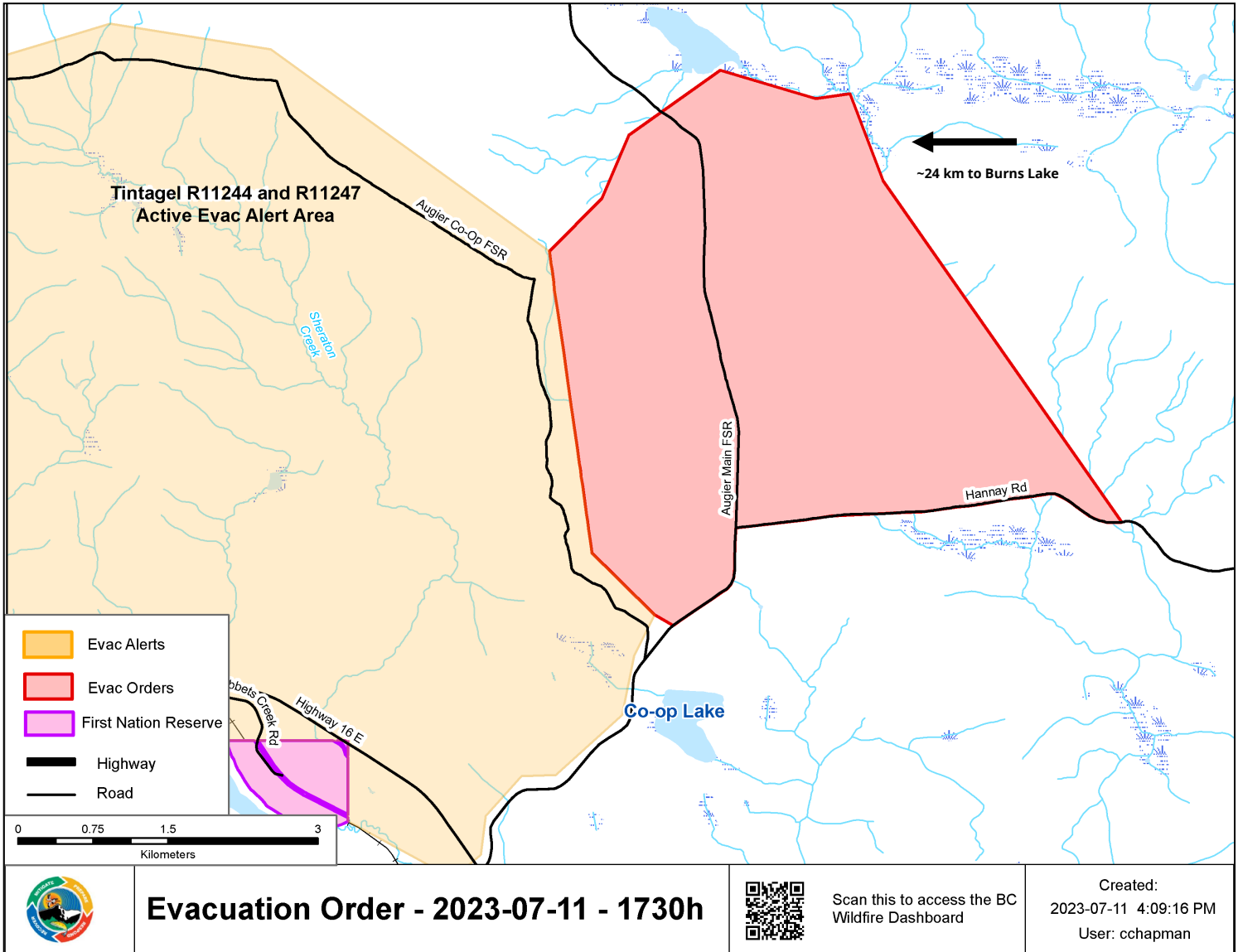

# EVACUATION ALERT AMENDMENT

## Tintagel Wildfire #R11244/R11247 EVACUATION ALERT AMENDMENT July 10, 2023 at 1700 hours

An Evacuation Alert Amendment, effective **July 10, 2023 at 1700 hours**, has been issued by the Regional District of Bulkley-Nechako because of the potential danger to **life and health**. This amends the Evacuation Alert Expansion area issued on **July 08, 2023 at 1930 hours**, by removing the following areas:

**All lands and properties accessed by Gowan, Wiebe, and Boer Mountain Roads south of the Kager Lake Campsite are no longer under evacuation alert, as shown on the attached map.**

An Evacuation Alert has been issued to prepare you to evacuate your premises or property should it be found necessary. Residents will be given as much advance notice as possible prior to evacuation; however, you may receive limited notice due to changing conditions.

### WHAT YOU SHOULD DO WHILE THIS ALERT IS IN EFFECT

Be prepared for an Evacuation Order by:

- Locate all family members or co-workers and plan to meet outside the evacuation area, should an evacuation be called while separated.
- Gather essential items such as medications, eyeglasses, valuable papers (i.e., insurance), immediate care needs for dependants and, if you choose, keepsakes (photographs, etc.). Have these items readily available for quick departure.
- Prepare to move any persons with mobility challenges and/or children.
- Moving pets and livestock to a safe area, if you require assistance, please call the Regional District of Bulkley-Nechako at 250-692-1553.
- Arranging to transport your household members or co-workers in the event of an evacuation order. If you are asked to evacuate and need transportation assistance from the area, please call 250-692-1553.

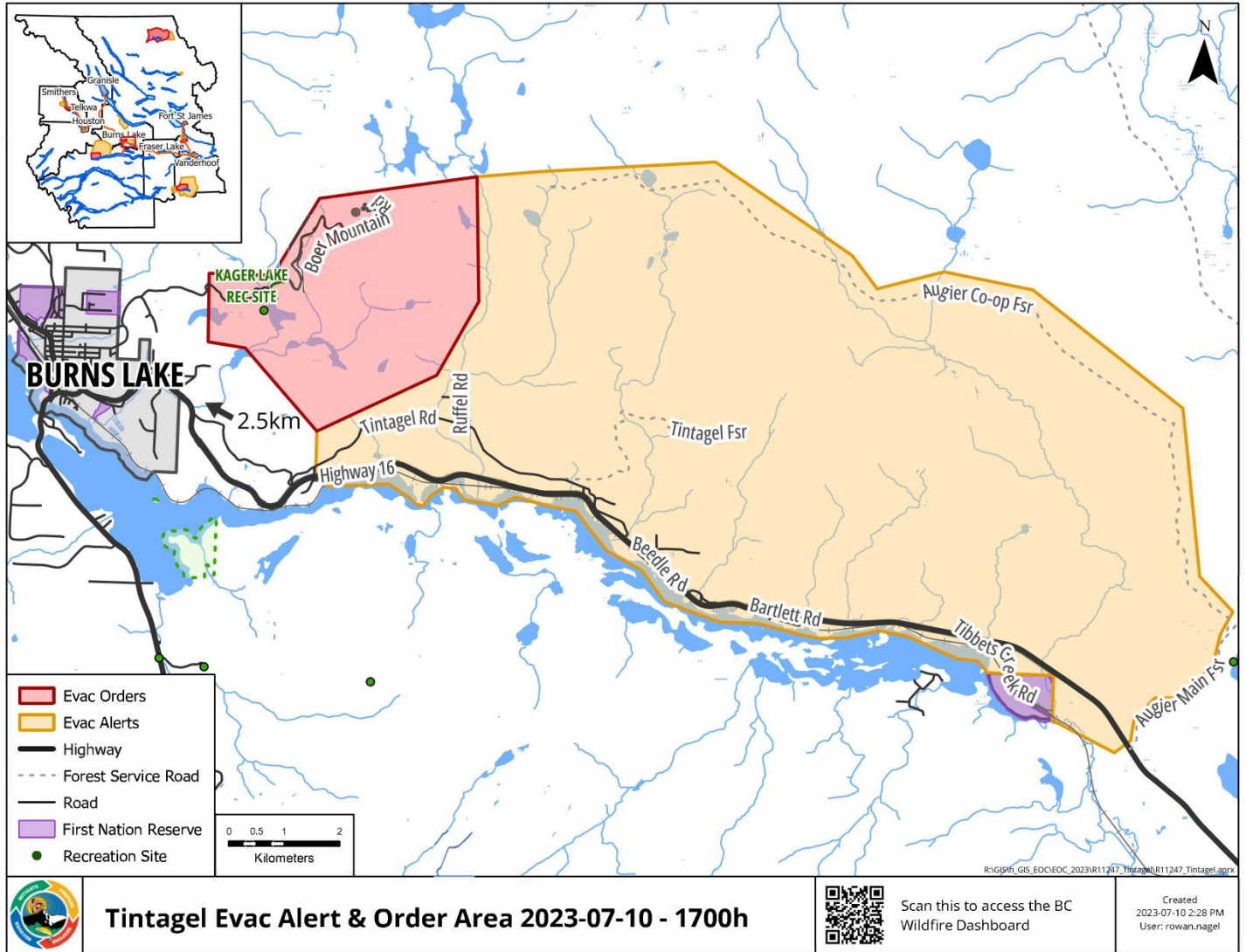

## **EVACUATION ORDER EXPANSION July 10, 2023 at 1700 hours**

An Evacuation Order Expansion, effective **July 10, 2023 at 1700 hours**, has been issued to **protect access to infrastructure and close recreation trails** by Recreation Sites and Trails BC, and the Regional District of Bulkley-Nechako. 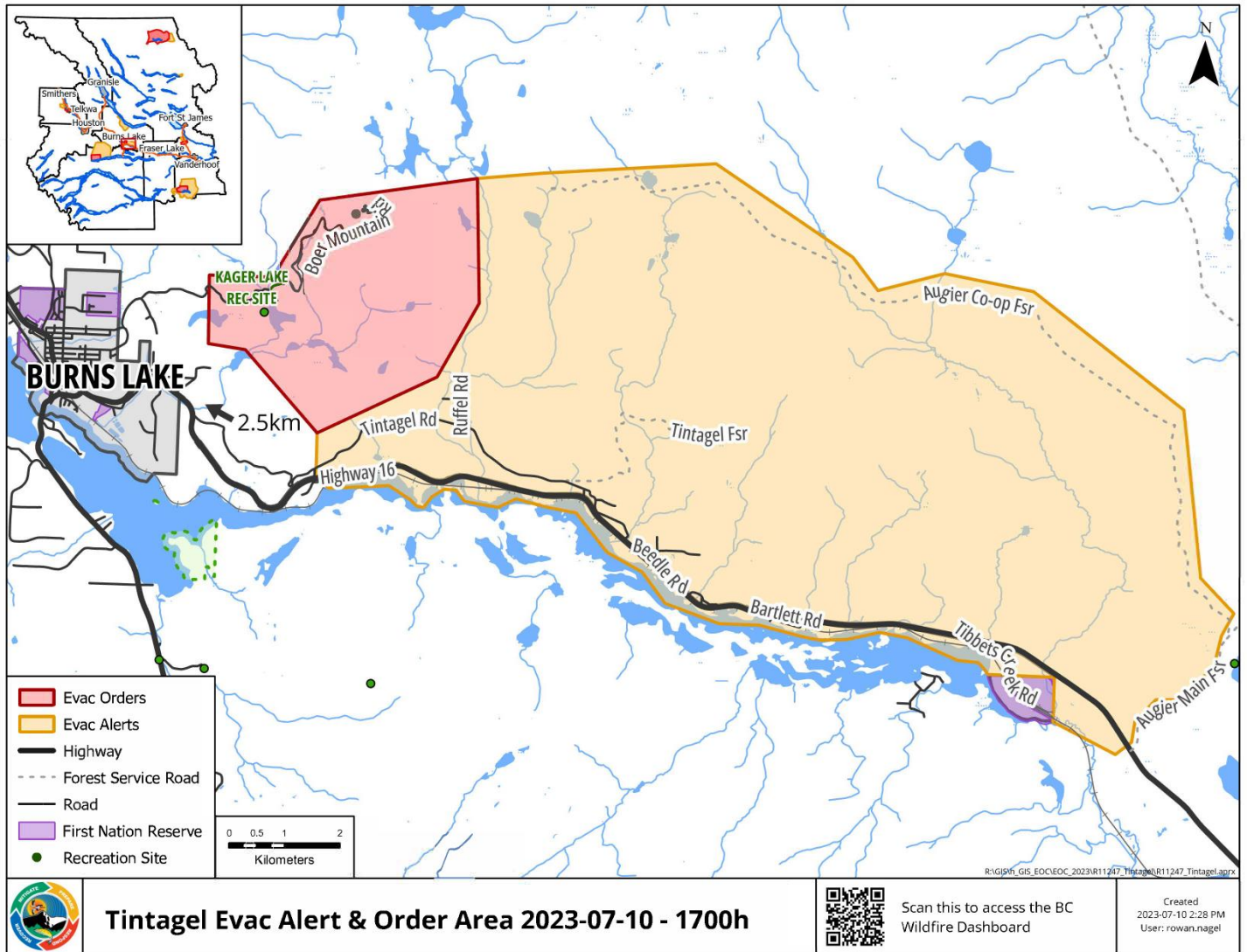

**All dwellings and property West of Burns Lake accessed by Gowan, Wiebe, or Boer Mountain Roads, as shown on the attached map.**

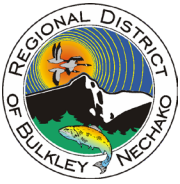

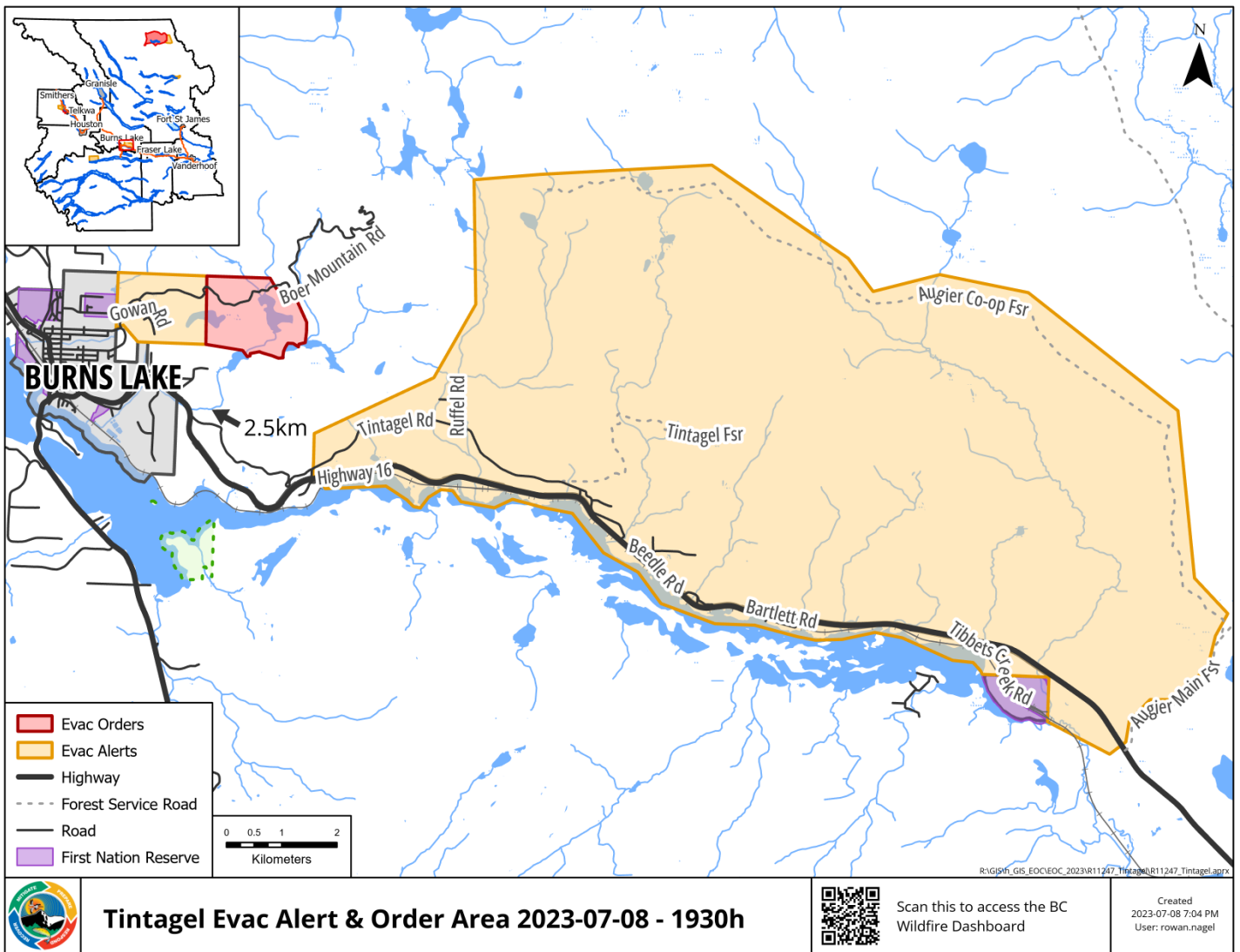

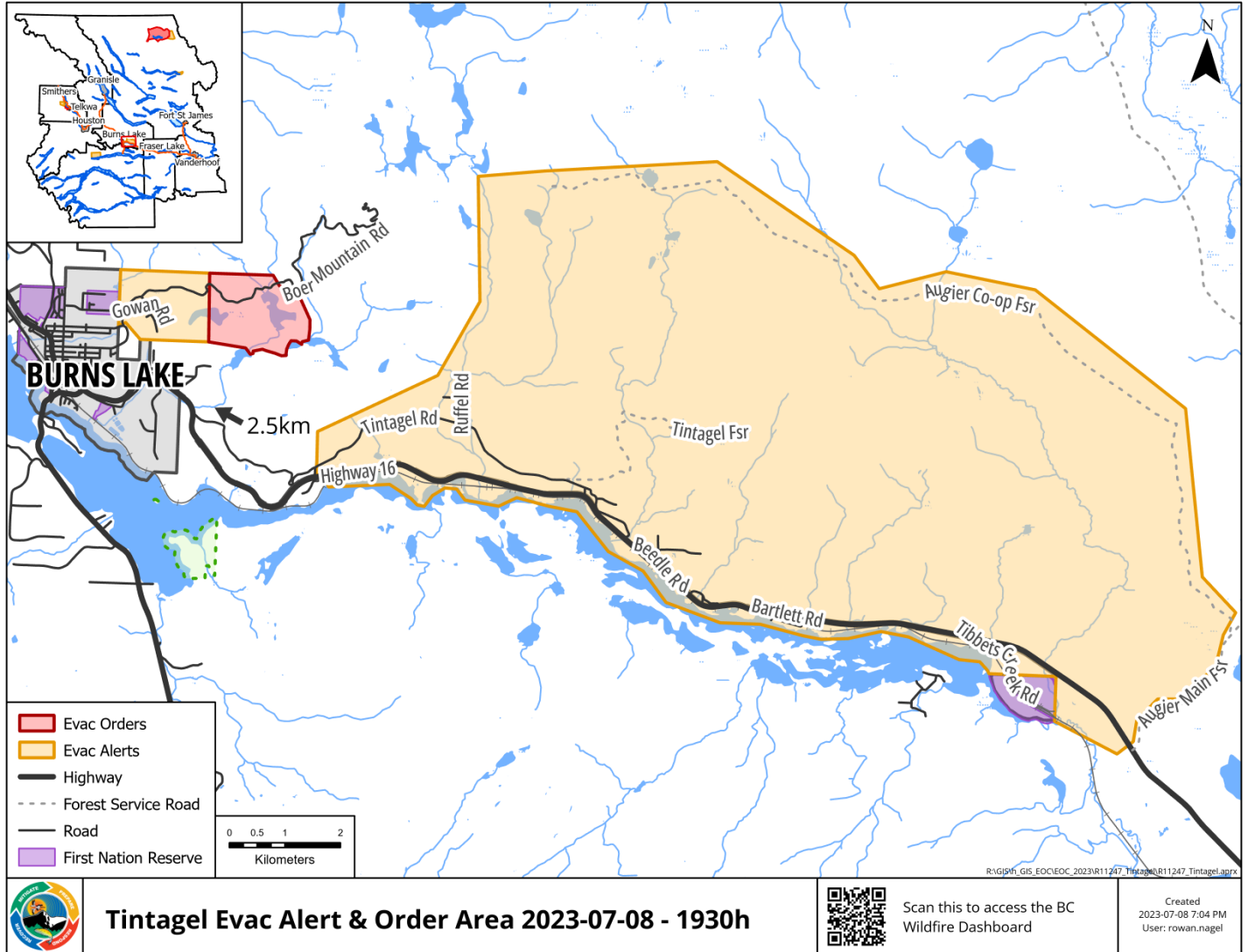

# EVACUATION ALERT

## **Tintagel Wildfire #R11244 and #R11247 EVACUATION ALERT ISSUED July 08, 2023, at 1000 hours**

Upon recommendations from BC Wildfire Service, an Evacuation Alert has been issued by the Regional District of Bulkley-Nechako effective July 08, 2023, at 1000 hours due to a wildfire.

Because of the potential **danger to life and health** the Regional District of Bulkley-Nechako has issued an Evacuation Alert **for all properties and lands located on the north side of Burns Lake, accessed off Highway 16 between the west end of Tintagel Road, and the Augier Main FSR, extending north to include the Augier Co-Op FSR, as shown on the attached map.**

An Evacuation Alert has been issued to prepare you to evacuate your premises or property should it be found necessary. Residents will be given as much advance notice as possible prior to evacuation, however, you may receive limited notice due to changing conditions.

### **WHAT YOU SHOULD DO WHILE THIS ALERT IS IN EFFECT**

Be prepared for an Evacuation Order:
