The Regional District of Fraser-Fort George and Regional District of Bulkley-Nechako are downgrading the joint Evacuation Order and rescinding the joint Evacuation Alert placed on the active wildland interface fire in the vicinity of Noonlang Lake (referred to as Ocock Lake Fire – G51344 by BC Wildfire Service). The Evacuation Alert is in effect for the area shown on the attached map.

### Evacuation Alert Area:

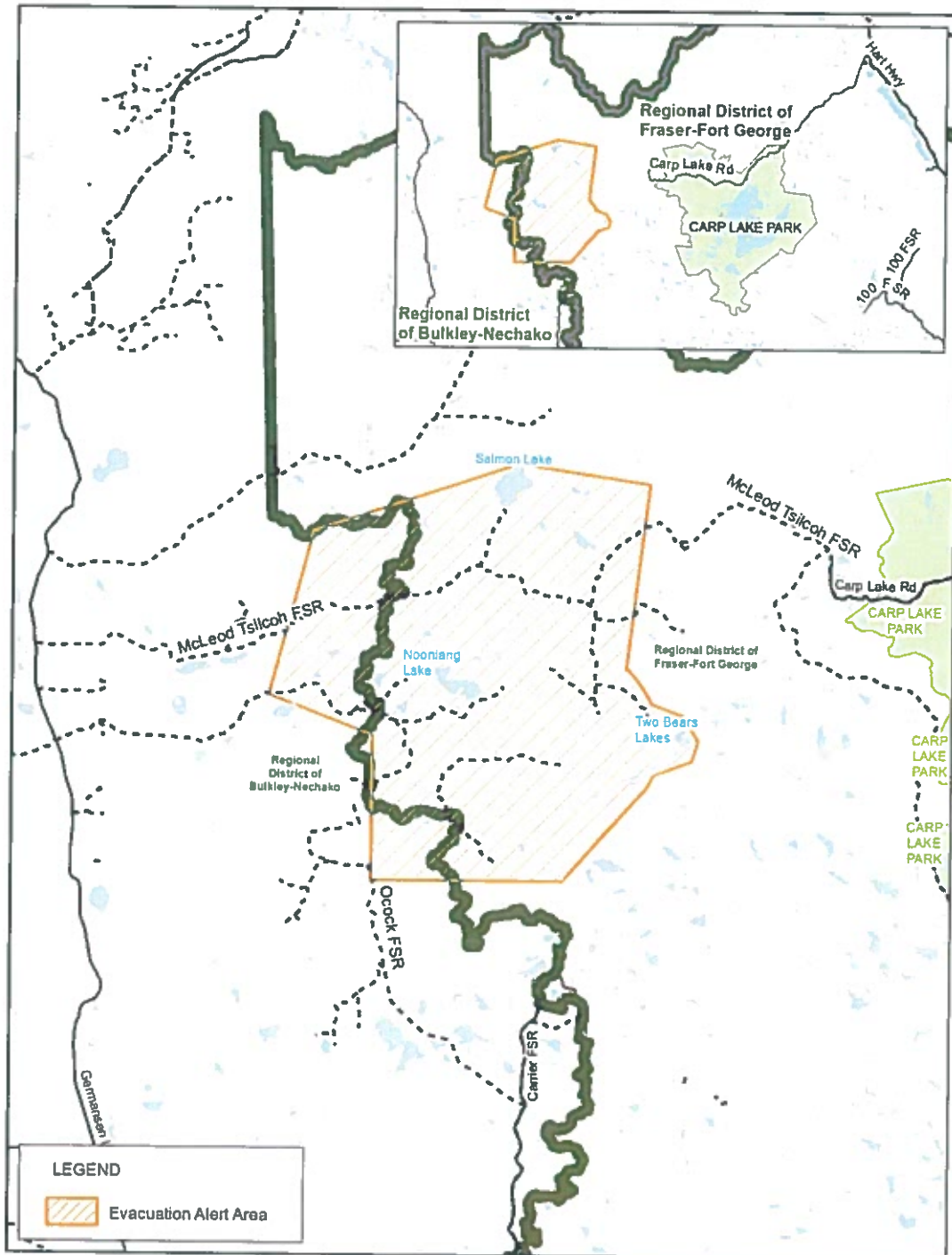

The Regional District of Fraser-Fort George and Regional District of Bulkley-Nechako are issuing a joint Evacuation Alert to the existing Evacuation Order due to an active wildland interface fire in the vicinity of Noonlang Lake (referred to as Ocock Lake Fire – G51344 by BC Wildfire Service). The Evacuation Order and Alert are in effect for the area shown on the attached map.

### Evacuation Order Area:

Based on this information, an order *pursuant to the Authority of Section 13(1) of the Emergency Program Act* to evacuate these areas has been authorized in the interest of life and safety.

**YOU MUST LEAVE THIS AREA IMMEDIATELY. CITIZENS MUST REMAIN AWAY FROM THE EVACUATION ORDER AREA AS CONDITIONS MAY CHANGE UNEXPECTEDLY AND FIRST RESPONDERS WILL NOT BE ABLE TO ASSIST THOSE IN THE EVACUATION ORDER AREA.**

Residents of the Evacuation Order Area are required to contact their respective Regional District to make arrangements for the provision of Emergency Support Services (ESS) such as food and lodging if needed.

# EVACUATION ALERT

## **SOUTH OF NOONLANG LAKE #G51344 EVACUATION ALERT ISSUED July 23, 2023 at 1500 hours**

Upon recommendations from BC Wildfire Service, an Evacuation Alert has been issued by the Regional District of Bulkley-Nechako due to a wildfire.

Because of the potential **danger to life and health**, the Regional District of Bulkley-Nechako has issued an Evacuation Alert **for all lands and properties in the area south of Noonlang Lake, as shown in the attached map.**

An Evacuation Alert has been issued to prepare you to evacuate your premises or property should it be found necessary. Residents will be given as much advance notice as possible prior to evacuation, however, you may receive limited notice due to changing conditions.

### **WHAT YOU SHOULD DO WHILE THIS ALERT IS IN EFFECT**

Be prepared for an Evacuation Order:

- Locate all family members or co-workers and plan to meet outside the evacuation area, should an evacuation be called while separated.
- Gather essential items such as medications, eyeglasses, valuable papers (i.e., insurance), immediate care needs for dependents and, if you choose, keepsakes (photographs, etc.), and have these items readily available for quick departure.
- Prepare to move any persons with mobility challenges and/or children.
- Move pets and livestock to a safe area. If you require assistance, please call the Regional District of Bulkley-Nechako.
- Arrange to transport your household members or co-workers in the event of an evacuation order. If you are asked to evacuate and need transportation assistance from the area, please call the Regional District of Bulkley-Nechako.
- Arrange accommodation for your family if possible.

In the event of an Evacuation Order, a Reception Centre will be opened if required, and evacuation routes specified.
