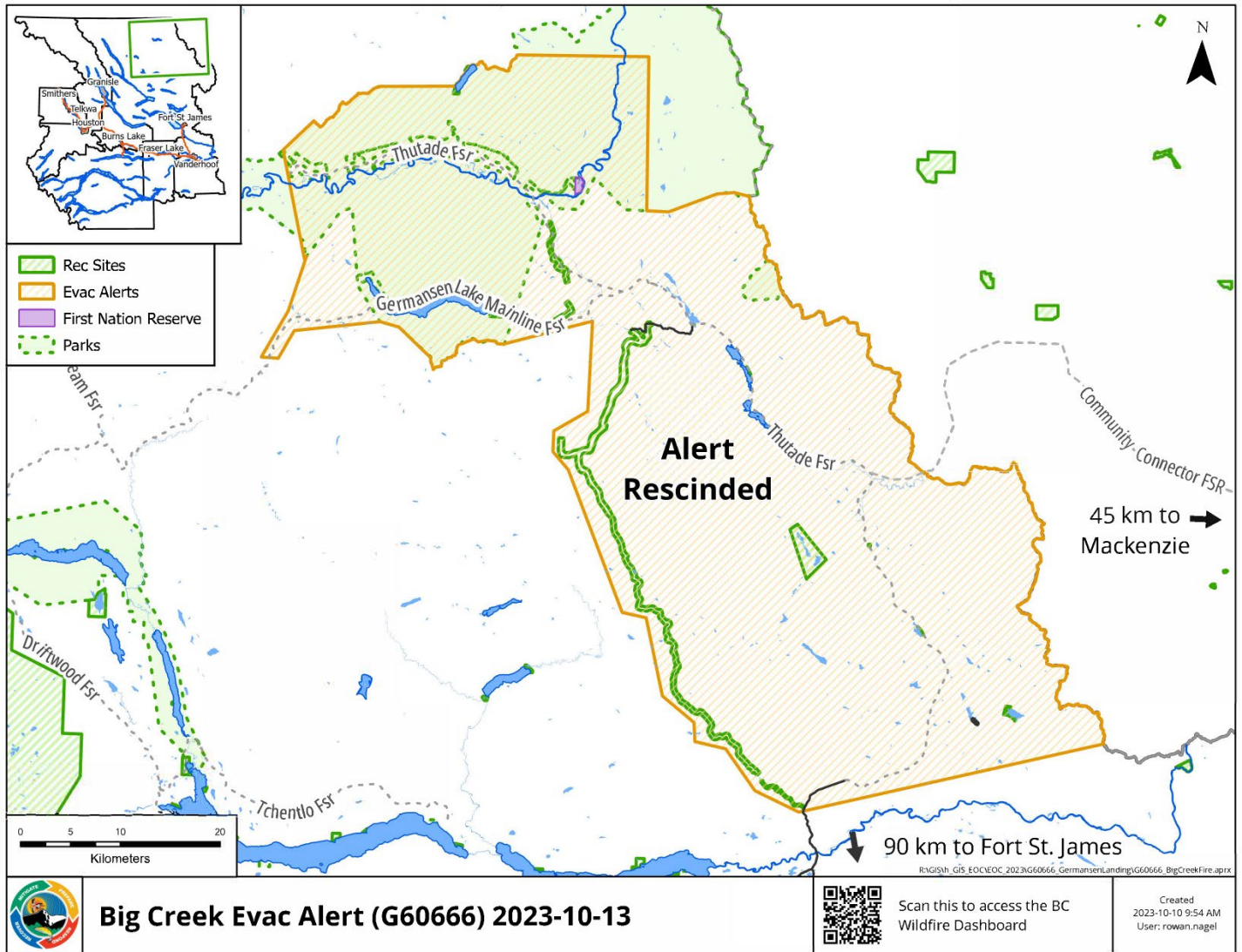
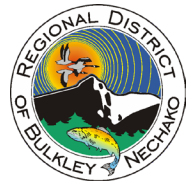

Upon recommendations from BC Wildfire Service, the **Evacuation Order** issued by Takla Nation, the Regional District of Bulkley-Nechako, BC Parks, and Recreation Sites and Trails BC on September 13, 2023 at 9:00 hours for the Big Creek Wildfire **has been rescinded, and is replaced by:**

The **Evacuation Alert** issued by Takla Nation, the Regional District of Bulkley-Nechako, BC Parks, and Recreation Sites and Trails BC on September 21, 2023 at 10:00 hours for the Big Creek Wildfire, **for all properties, lands, and dwellings in the Germansen Landing and 12 Mile area, accessed off Thutade Forest Service Road (FSR), including the North Takla Lake 12 Reserve. Additionally, lands accessed by the Germansen Lake Mainline FSR, including areas of the Omineca Provincial Park and private resource operations west of Germansen Lakes. As well as all properties, lands, and dwellings in the Manson Creek community and to the south that are located between the Regional District of Bulkley-Nechako boundary and the Baldy Mountain Trail Recreation Reserve, north of the Nation River as well as properties, including those accessed by Thutade FSR or Omineca Mining Access Road, as shown on the attached map.**

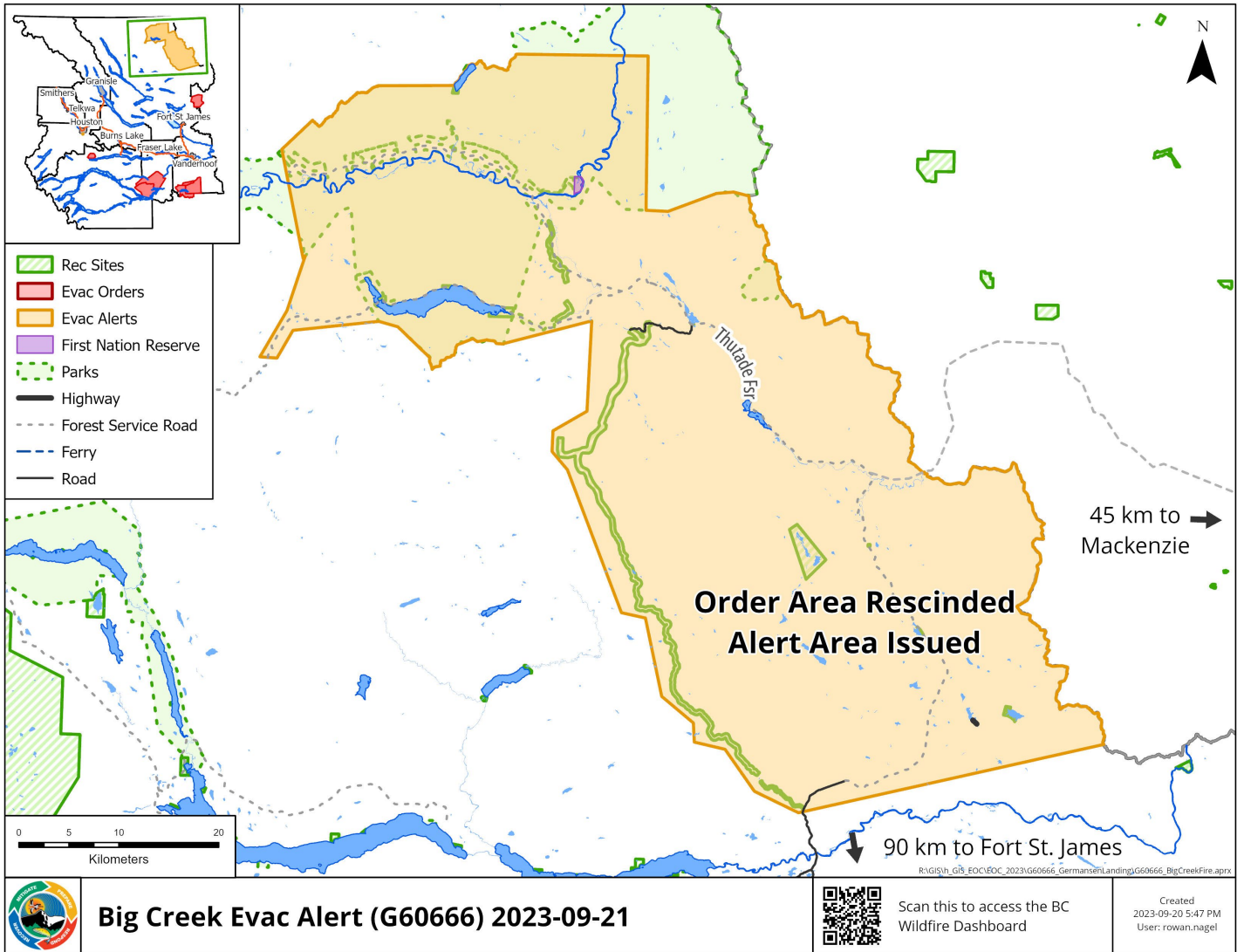

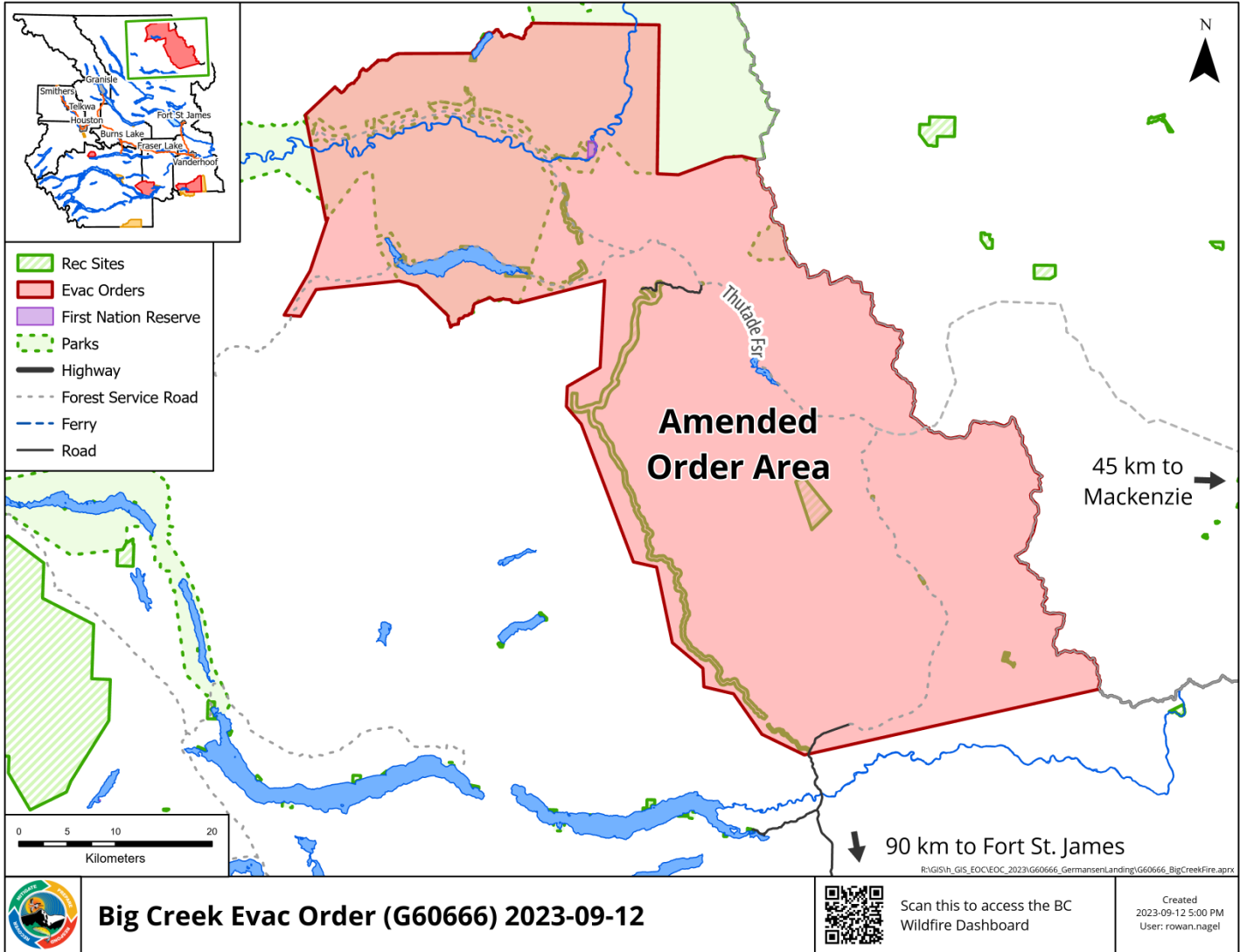

## **BIG CREEK WILDFIRE #G60666 EVACUATION ALERT AMENDMENT ISSUED September 11, 2023 at 2100 hours**

Upon recommendations from BC Wildfire Service, the Evacuation Alert Issued on August 21, 2023 at 1730 is being amended by BC Parks, Recreation Sites and Trails BC and the Regional District of Bulkley-Nechako due to a wildfire.

**Due to access and egress to the area being compromised and the danger to life and health**, BC Parks, Recreation Sites and Trails BC and the Regional District of Bulkley-Nechako have issued an Evacuation Alert Amendment for the Big Creek Wildfire, **for all lands and properties to the south that are located between the Regional District of Bulkley-Nechako boundary and the Baldy Mountain Trail Recreation Reserve, north of the Nation River as well as properties, and dwellings previously under Evacuation Alert, in or near the Manson Creek community, including those accessed by Thudade FSR or Omineca Mining Access Road, as shown on the attached map.**

An Evacuation Alert has been issued to prepare you to evacuate your premises or property should it be found necessary. Residents will be given as much advance notice as possible prior to evacuation, however, you may receive limited notice due to changing conditions.

- Arrange to transport your household members or co-workers in the event of an evacuation order. If you are asked to evacuate and need transportation assistance from the area, please call the Regional District of Bulkley-Nechako.
- Arrange accommodation for your family if possible.

In the event of an Evacuation Order, a Reception Centre will be opened if required, and evacuation routes specified.
