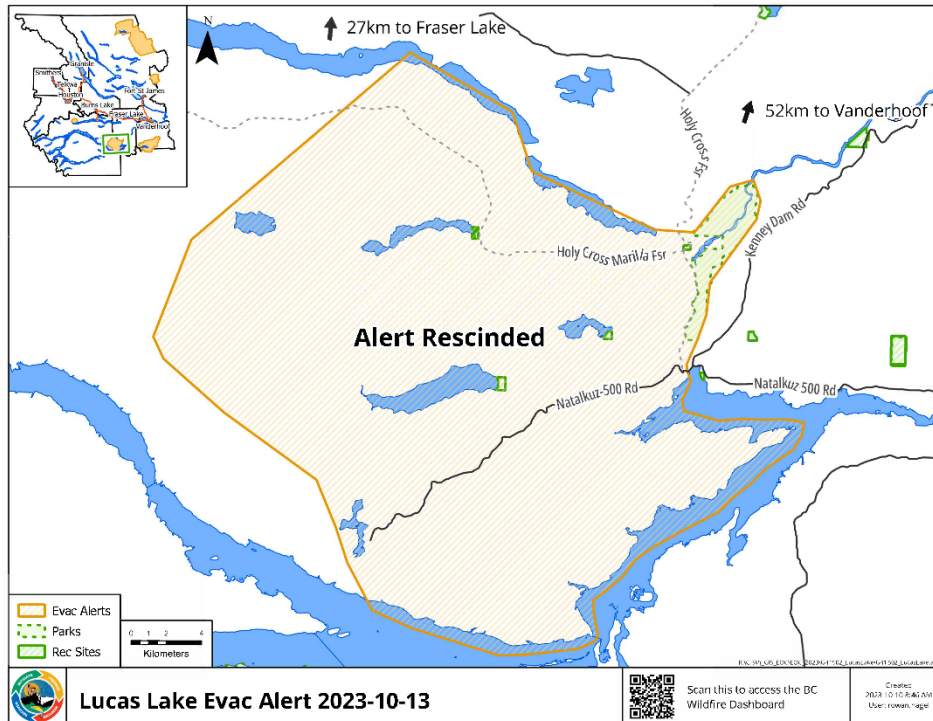

LUCAS LAKE WILDFIRE #G41380 EVACUATION ORDER RESCINDED EVACUATION ALERT ISSUED IN PLACE October 3, 2023 at 1500 hours

Upon recommendations from BC Wildfire Service, the Evacuation Order issued September 10, 2023 at 1730 hours by BC Parks, Recreation Sites and Trails BC, and the Regional District of Bulkley-Nechako for the Lucas Lake Wildfire has been rescinded and is replaced by:

This **Evacuation Alert** issued by BC Parks, Recreation Sites and Trails BC, and the Regional District of Bulkley-Nechako, **for all lands, properties, and dwellings for all lands and properties in the vicinity of Kenney Dam and south of the Cheslatta Lake, including the entire Nechako Canyon Protected Area. Additionally, lands and properties accessed by the Nataalkuz 500, Holy Cross Marilla, and Marilla Main Forest Service Roads may be affected, as shown on the attached map.**

The Evacuation Alert has been issued to prepare you to evacuate your premises or property should it be found necessary. Residents will be given as much advance notice as possible prior to evacuation, however, you may receive limited notice due to changing conditions.

WHAT YOU SHOULD DO WHILE THIS ALERT IS IN EFFECT

Be prepared for an Evacuation Order:

- Locate all family members or co-workers and plan to meet outside the evacuation area, should an evacuation be called while separated.
- Gather essential items such as medications, eyeglasses, valuable papers (i.e., insurance), immediate care needs for dependents and, if you choose, keepsakes (photographs, etc.), and have these items readily available for quick departure.
- Prepare to move any persons with mobility challenges and/or children.
- Move pets and livestock to a safe area. If you require assistance, please call the Regional District of Bulkley-Nechako.
- Arrange to transport your household members or co-workers in the event of an evacuation order. If you are asked to evacuate and need transportation assistance from the area, please call the Regional District of Bulkley-Nechako.
- Arrange accommodation for your family if possible.

In the event of an Evacuation Order, a Reception Centre will be opened if required, and evacuation routes specified.

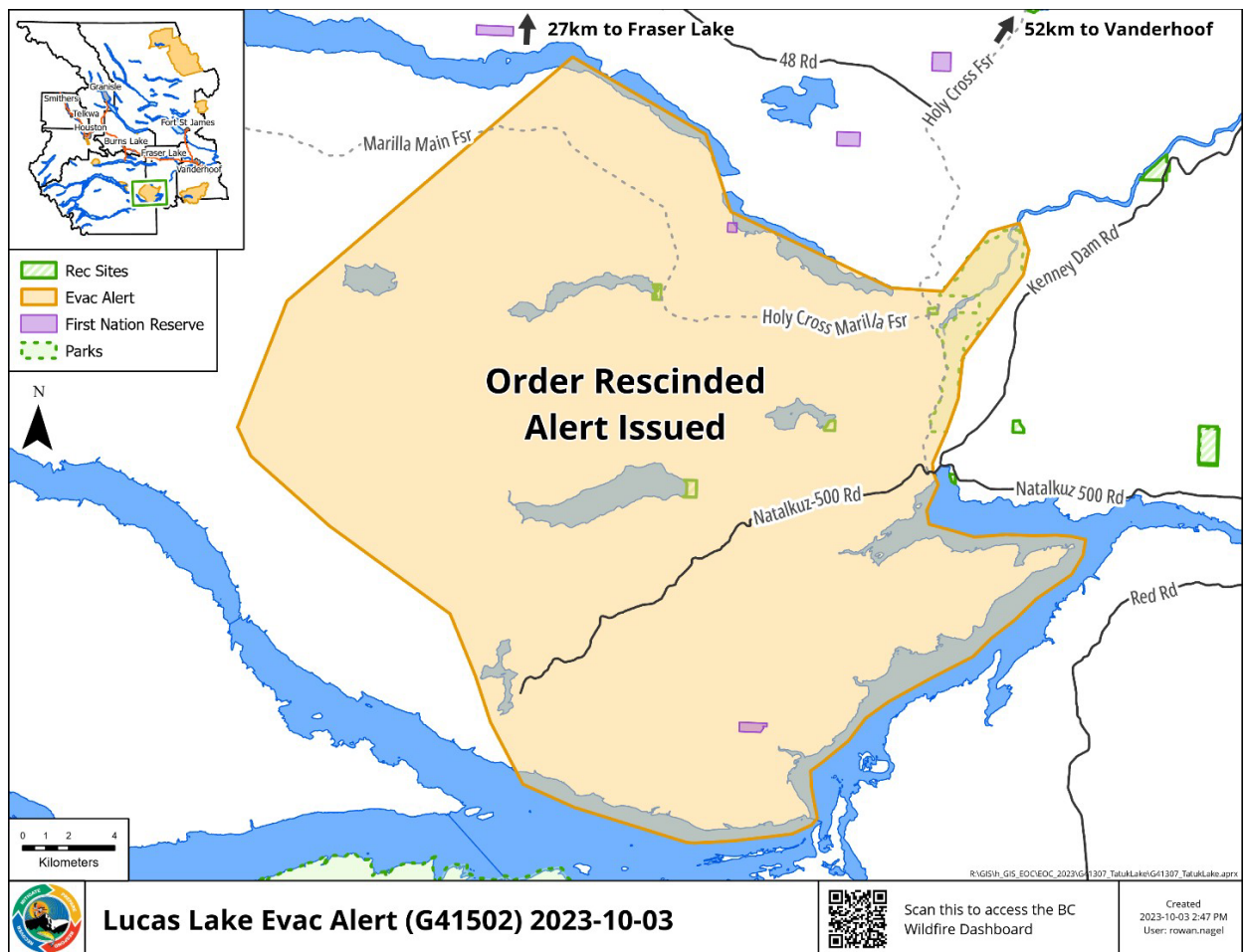

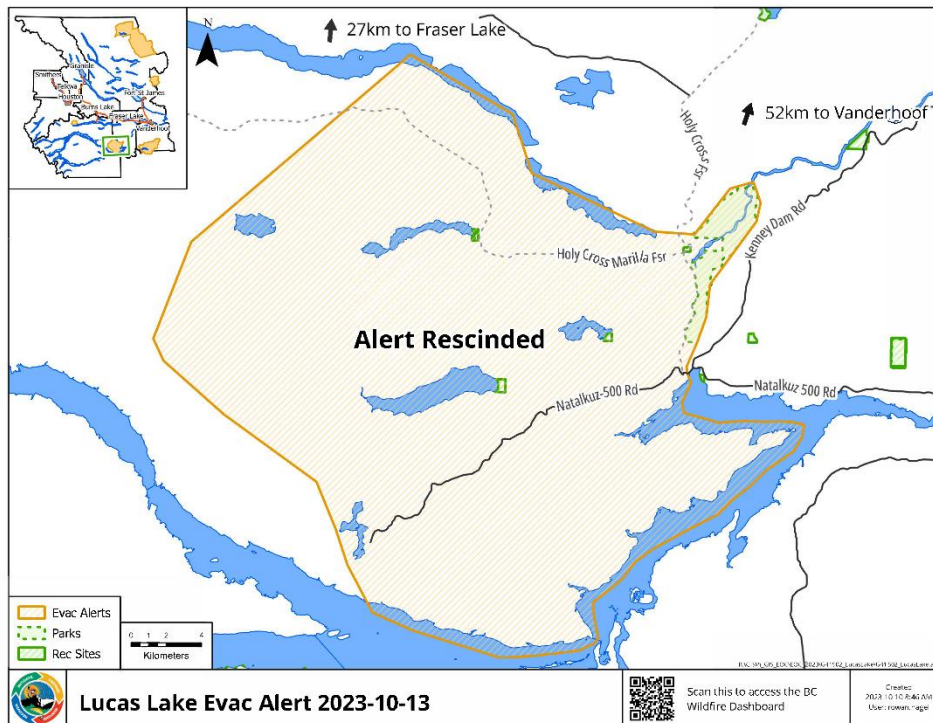

Upon recommendations from BC Wildfire Service, the Evacuation Order Amendment issued on September 15, 2023 at 1800 hours for the Lucas Lake Wildfire is amended as follows:

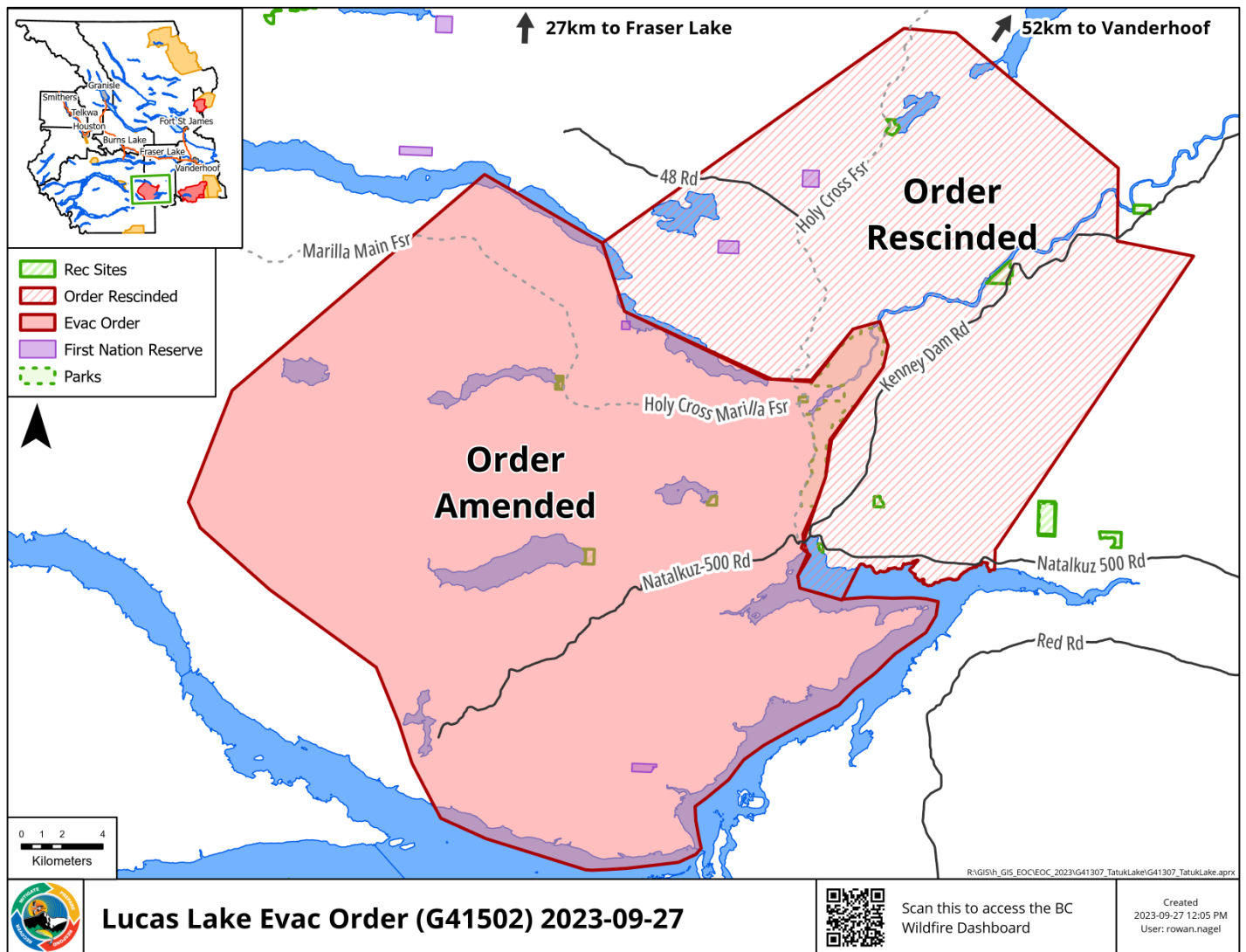

Upon recommendations from BC Wildfire Service, the Evacuation Order issued on September 3, 2023 at 1700 hours and the Evacuation Alert Expansion issued on September 10, 2023 at 1730 hours for the Lucas Lake Wildfire is amended as follows:

The Evacuation Alert Expansion issued by the Regional District of Bulkley-Nechako on September 10, 2023 at 1730 hours **has been rescinded and is being replaced by:**

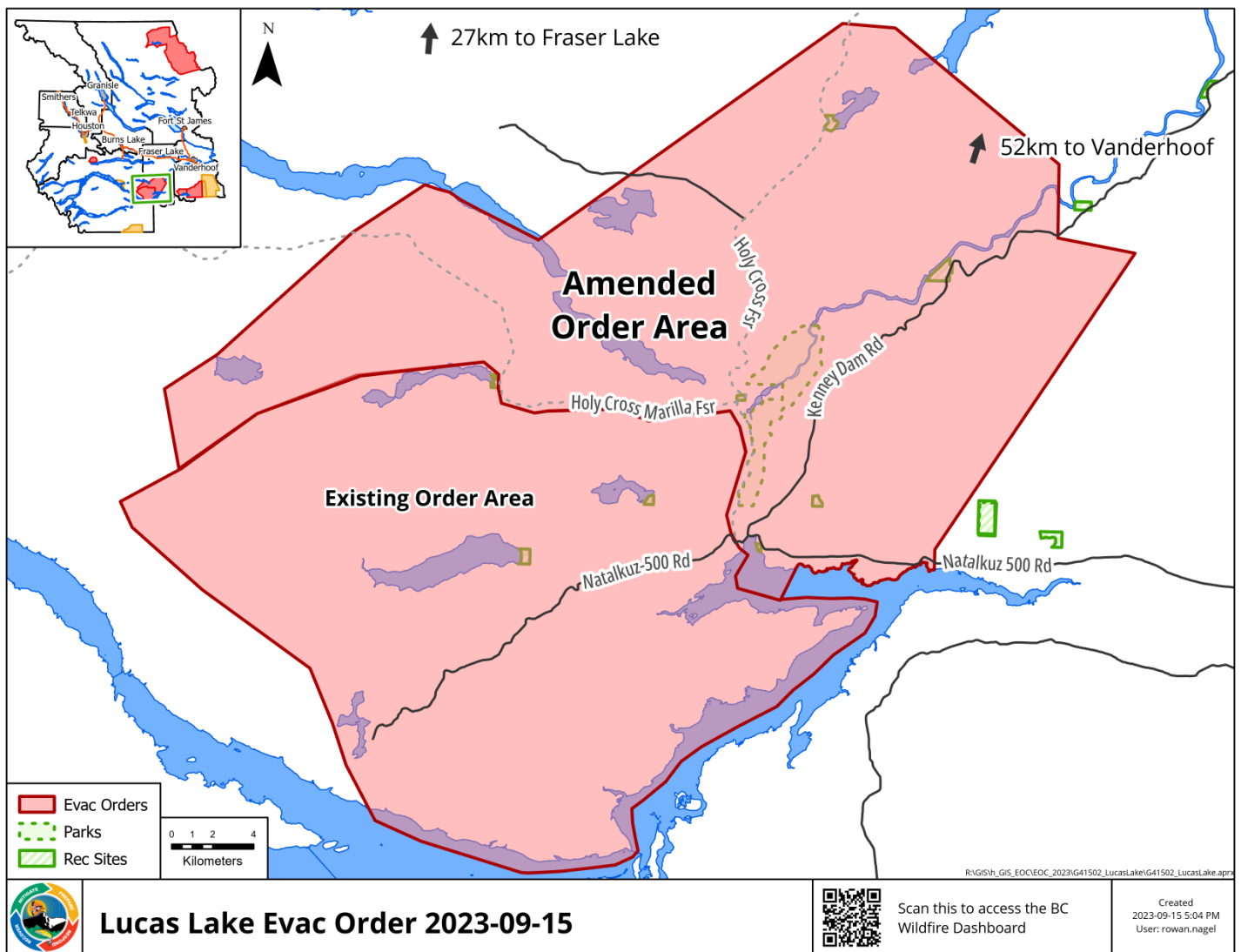

EVACUATION ALERT EXPANSION

LUCAS LAKE WILDFIRE #G41380 EVACUATION ALERT EXPANSION September 10, 2023 at 1730 hours

Upon recommendations from BC Wildfire Service, the **Evacuation Alert issued August 1, 2023 at 1030 hours** for the Lucas Lake Wildfire is being **expanded and includes all lands and properties directly to the east of Kenny Dam and 6.8 km east along the Nataalkuz 500 Road, as shown on the attached map.**

The Evacuation Order issued September 3, 2023 at 1700 hours remains in place for all lands and properties to the West of Kenney Dam accessed off the Holy Cross Marilla Forest Service Road and the Nataalkuz 500 Road, including the Lucas Lake, Bird Lake, and Rum Cache Lake Recreation sites. The Marilla Main, Holy Cross-Marilla, and Holy Cross Forest Service Roads remain unaffected by this order, as shown on the attached map.

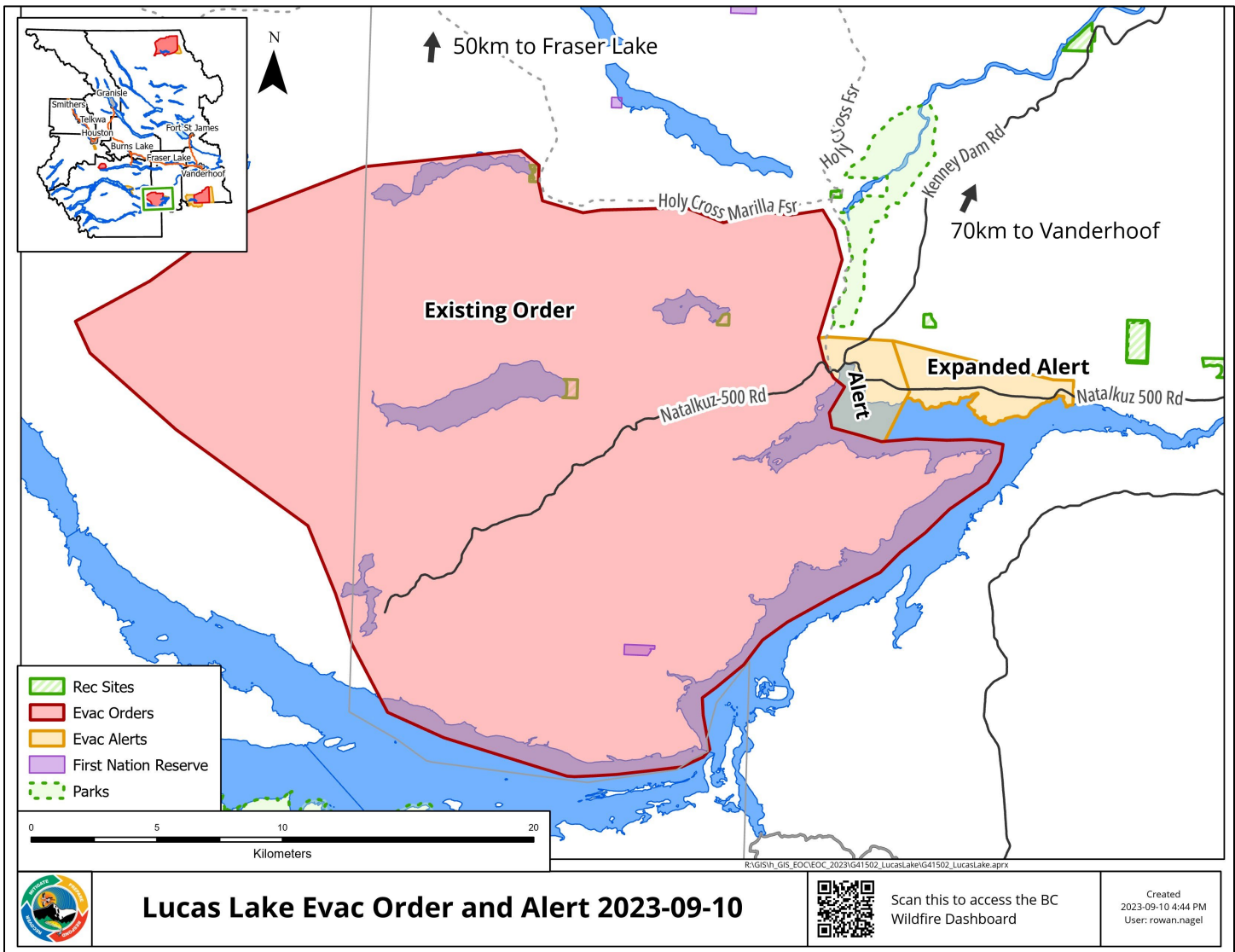

Upon recommendations from BC Wildfire Service, an Evacuation Order has been issued by the Regional District of Bulkley-Nechako due to a wildfire.

Because of the **danger to life and health**, the Regional District of Bulkley-Nechako has issued an Evacuation Order for the Lucas Lake Wildfire, **for all lands and properties to the West of Kenney Dam accessed off the Holy Cross Marilla Forest Service Road and the Natalkuz 500 Road, including the Lucas Lake, Bird Lake, and Rum Cache Lake Recreation sites. The Marilla Main, Holy Cross-Marilla, and Holy Cross Forest Service Roads remain unaffected by this order, as shown on the attached map.**

The Evacuation Alert issued by the Regional District of Bulkley-Nechako on August 1, 2023 at 1030 hours remains in place for all lands and properties directly to the east of Kenney Dam.

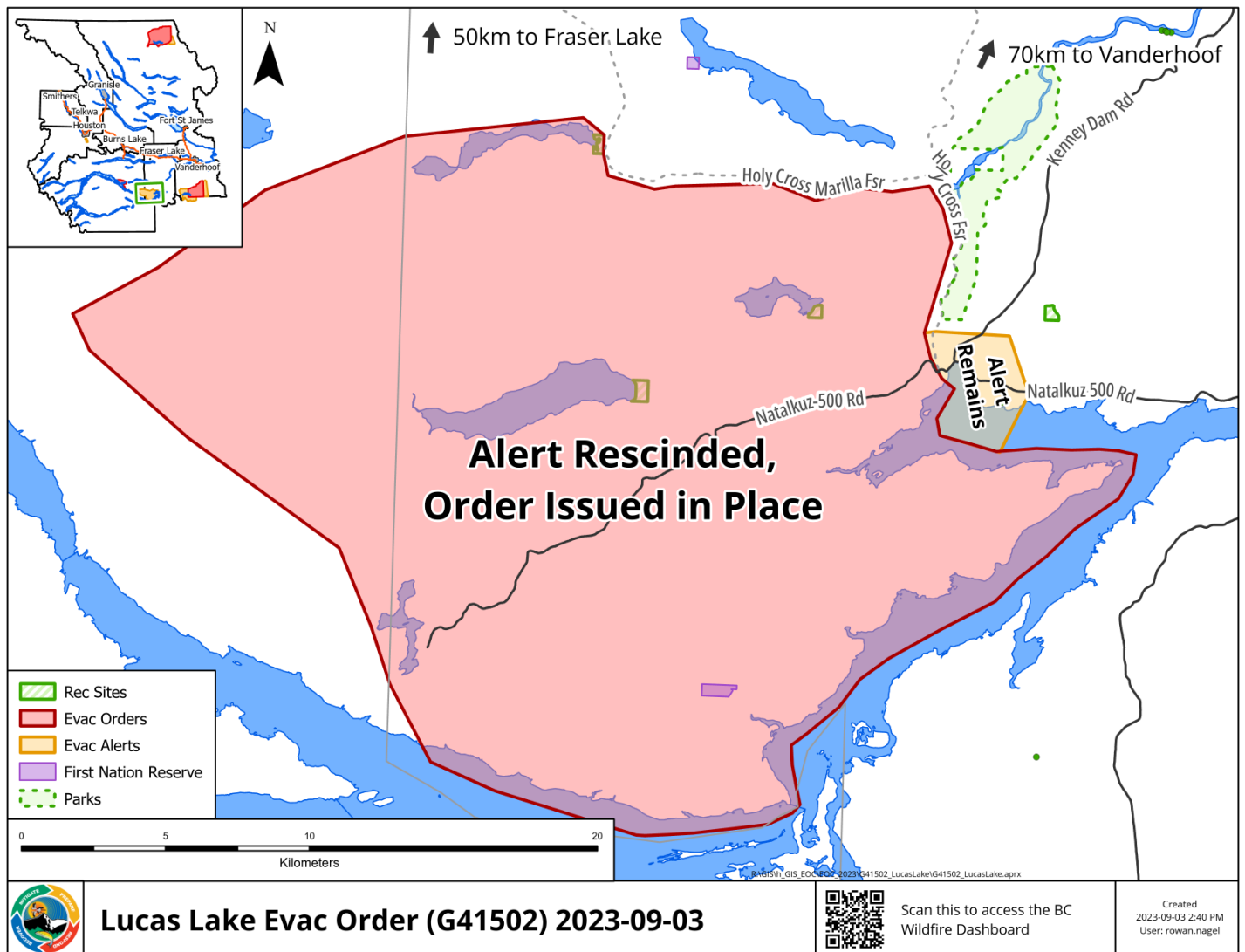

The **Evacuation Orders** issued by the Regional District of Bulkley-Nechako on July 12, 2023 at 2130 and July 16, 2023 at 1530 **have been rescinded**.

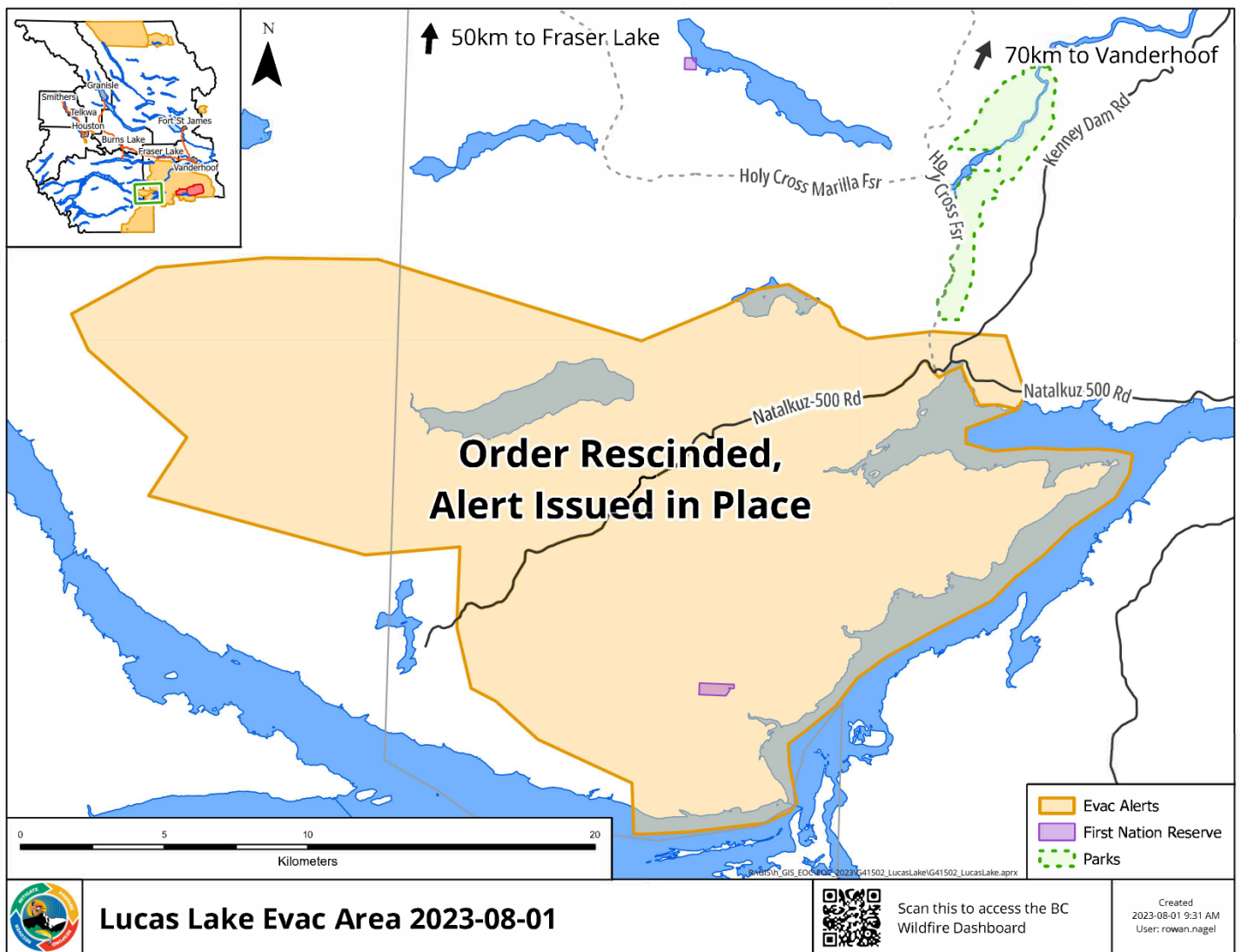

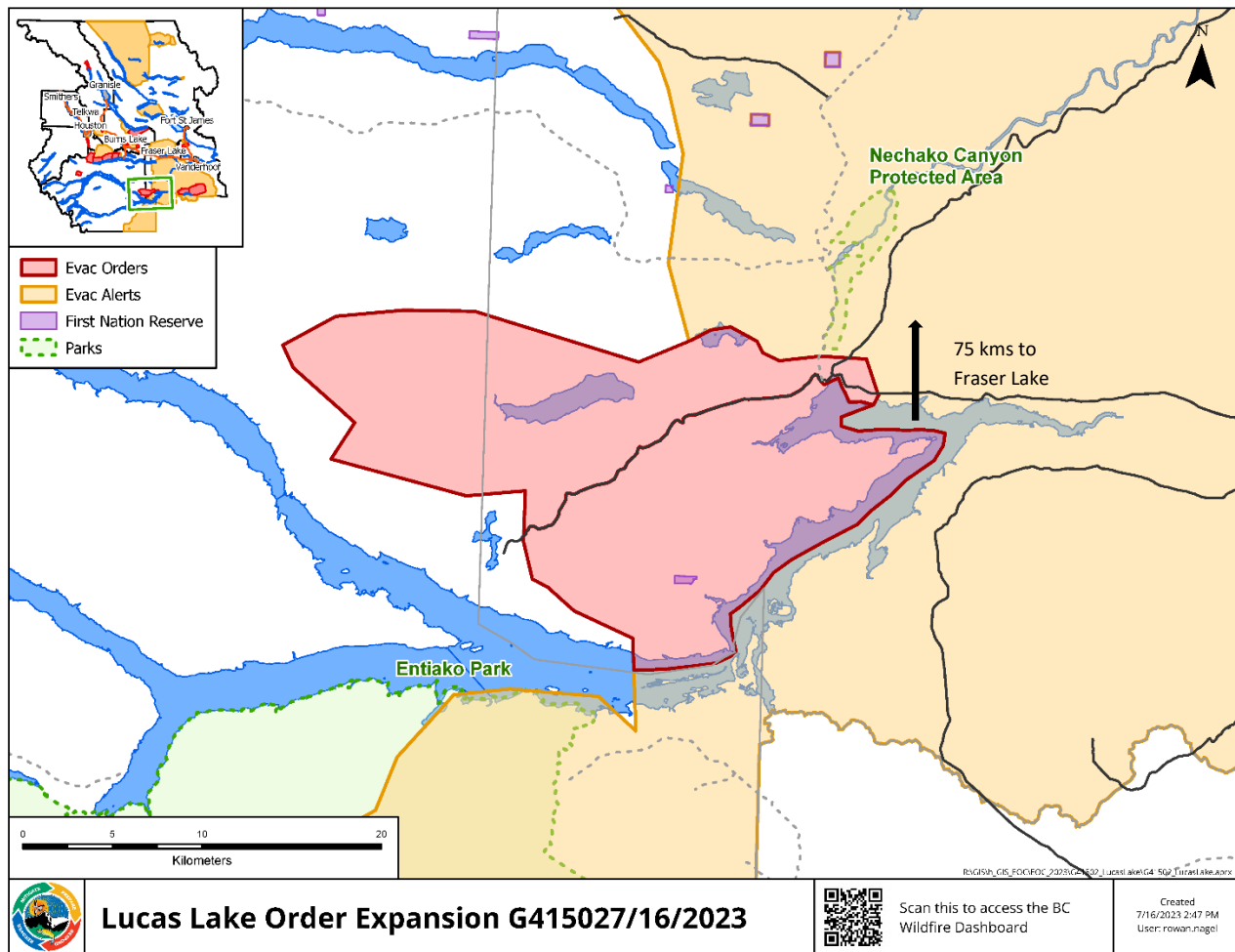

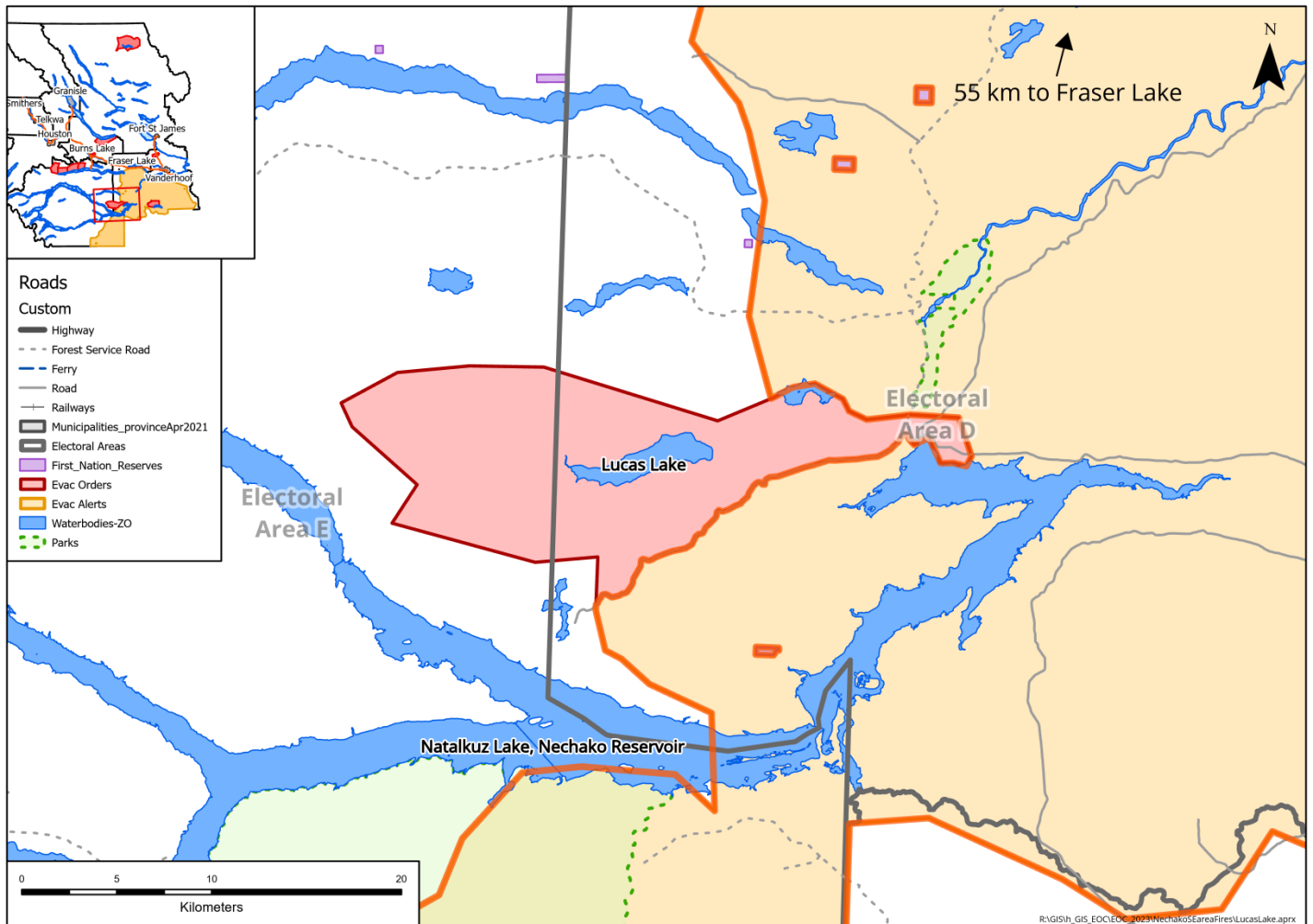
