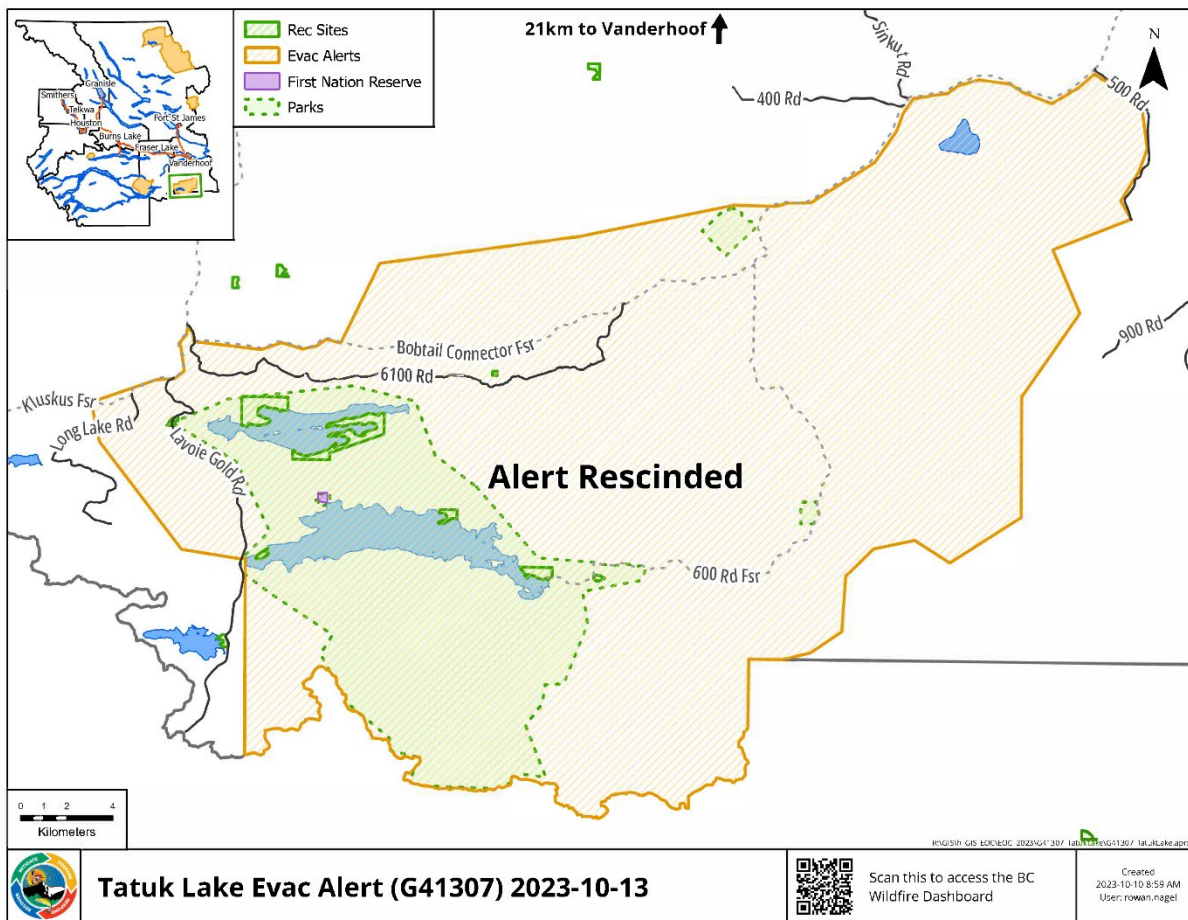

Upon recommendations from BC Wildfire Service, the Evacuation Order issued September 27, 2023 at 1400 hours for the Tatuk Lake Wildfires has been rescinded and is replaced by:

The **Evacuation Alert** issued by Saik'uz First Nation, BC Parks, Recreation Sites and Trails BC, and the Regional District of Bulkley-Nechako on October 3, 2023 at 1500 hours for the Tatuk Lake Wildfires, **for all lands, properties, and dwellings or all lands and properties in the vicinity of Finger and Tatuk Lakes, including the Finger-Tatuk Park, south of the Bobtail Connector Forest Service Road. Additionally, lands and properties accessed by Kluskus, Long Lake, and Lavoie Gold Roads may be affected, as shown on the attached map.**

Upon recommendations from BC Wildfire Service, the Evacuation Alert issued on August 21, 2023 at 2200 hours for the Tatuk Lake Wildfire is amended to the following:
