



## JANUARY 2024 BOARD HIGHLIGHTS

### Delegations

#### Ministry of Forests

At its January 11<sup>th</sup> meeting the Board received presentations regarding the Prince George, Lakes and Morice Timber Supply Area Apportionments as well as a second collaborative presentation from the Ministry of Forests and Lake Babine Nation regarding the Morice Timber Supply Area (TSA) Pilot Project and Lakes TSA Pilot Project.

#### Fraser Basin Council (Nechako Watershed Roundtable)

The Fraser Basin Council provided an update to the Board, with a focus on the Nechako Watershed Roundtable, at its January 25<sup>th</sup> meeting.

#### Parks and Trails Master Plan for Electoral Areas B (Burns Lake Rural) and E (Francois/Ootsa Lake Rural)

At its January 25<sup>th</sup> meeting the Board received the Parks and Trails Master Plan for Electoral Areas B (Burns Lake Rural) and E (Francois/Ootsa Lake Rural). The Plan is intended to serve as a long-term guiding document for the Regional District's provision of parks and trails services in Electoral Areas B and E. #### Canada Community Building Fund BC

##### Area A (Smithers/Telkwa Rural) Bulkley Valley Youth Sport Foundation

The Board authorized contributing up to \$180,000 of Electoral Area A (Smithers/Telkwa Rural) allocation monies to the Bulkley Valley Youth Sport Foundation for a Recreation Infrastructure project at the Telkwa tennis courts.

##### Area G (Houston/Granisle Rural) Houston Flyers Club

The Board authorized contributing up to \$80,000 of Electoral Area G (Houston/Granisle Rural) allocation monies to the Houston Flying Club for a Local Airport Infrastructure project at the Houston Airport.

#### Grant in Aid for Area F (Vanderhoof Rural)

The Board approved allocating \$5,000 in Electoral Area F (Vanderhoof Rural) Grant in Aid monies to the Vanderhoof Children's Theater for the Lion King production.

#### Emergency and Disaster Management Act (EDMA)

At its January 25<sup>th</sup> meeting the Board approved sending a letter to the Premier and Minister of Emergency Management & Climate Readiness regarding the RDBN's concerns on the *Emergency and Disaster Management Act*.
